**Sub: Release an amount of Rs. 358.31 lakh (Rupees three Hundred Fifty Eight Lakh and Thirty One Thousand only) for 91 cities of Maharashtra as the 1<sup>st</sup> installment of Central share for the preparation of HFAPoA – reg.**

Sir,

The undersigned is directed to convey the sanction of the President of India to the amount of **Rs. 358.31 lakh (Rupees three Hundred Fifty Eight Lakh and Thirty One Thousand only)** for 91 cities of Maharashtra as the 1<sup>st</sup> installment of Central share for the preparation of HFAPoA. A list of towns/cities for which first installment is being released is annexed.

2. The above grant is subject to the following conditions:

- I. The above amount is first installment of grants approved as per the financial norms approved by 1<sup>st</sup> CSMC under HFA held on 17<sup>th</sup> September 2015. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- II. The above release is only for those cities which are approved by this Ministry under HFA mission.
- III. The Grant sanctioned will be utilized for the purpose for which it is released. The State Government/Nodal Agency shall furnish physical and financial progress reports (every quarter).
- IV. State Government of **Maharashtra** is required to furnish Utilization Certificate as per GFR and Statement of Expenditure to the Government of India as soon as the fund utilization exceeds 70% of the amount released.
- V. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.

- VI. The amount of central assistance approved will form a part of capacity building plan of the State under PMAY-HFA (Urban) Mission.
- VII. Where there is an element of cash transfer the same may be made through PFMS/DBT mode as applicable.

3. The expenditure is debitable to the following Head of Account under Demand No. 50 (Plan) of M/o Housing and Urban Poverty Alleviation for the year 2016-17:
