Sub: Release of Rs. 58,80,000/- as 2nd installment of Central Assistance to the State Government of Madhya Pradesh under Pradhan Mantri Awas Yojana (PMAY) - Housing for All (Urban) Mission for the financial year 2017-18 - reg.

Sir,

I am directed to convey the Sanction of the President of India to the release of Rs. 58,80,000/- (Rupees Fifty-Eight Lakh and Eighty Thousand only) to the State Government of Madhya Pradesh as 2nd installment of central grant for Creation of Capital Assets under Pradhan Mantri Awas Yojana (PMAY)- Housing for All (Urban) Mission under allocation (STC component) for the FY 2017-18. Details of the projects are as follows:

2. Based on decision of CSMC under Pradhan Mantri Awas Yojana (PMAY) - Housing for All (HFA) (Urban) Mission in its 20th CSMC and on the recommendations made by MoHUPA, the amount of central grant is being released subject to following conditions along with observations of CSMC:

- Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
- The States Government and implementing agency shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme of Pradhan Mantri Awas Yojana (PMAY) - Housing for All (HFA) (Urban) Mission.
- Furnish the Utilization certificates of the Grant released in the prescribed format as per GFR-2017 as provided in the scheme guidelines.
- The funds may be utilized for the purpose for which these are given. Otherwise these will have to be refunded along with interest as per provisions for GFR-2017.
- State to expedite the entry in the PMAY-MIS.
- The State must ensure geo-tagging of photographs to monitor progress of the house construction before release of each installment to beneficiaries.
- The agencies responsible for implementation of PMAY should get themselves registered on PFMS portal.
- The State Government should ensure that the grant under PMAY is transferred to the beneficiaries based upon the proportionate physical progress of construction level, so that the beneficiaries have incentive to complete the construction in time.

- x. Transfer of funds to different entities may be made through PFMS, as applicable, and where there is an element of cash transfers to individual beneficiaries, the same may be made through PFMS/DBT mode, as applicable.
 - xi. The State should ensure quality of the construction of the houses as per the defined norms and guidelines.
3. Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
4. The amount is debitible from the account of the Central Government in the books under the following Head of Account under Demand No. 56 M/o Housing and Urban Poverty Alleviation for the year 2017-18:
