In continuation of this Ministry's sanction of even number dated 28.03.2017, the undersigned is directed to convey the Sanction of the President of India to the payment of Rs. 22,20,000/- (Rupees Twenty two lakhs twenty thousand only) to the State Government of Kerala as balance of central assistance (Scheduled Caste Component) for Creation of Capital Assets under Pradhan Mantri Awas Yojana (Urban) for the FY 2017-2018.

- 2. A statement showing details of the 11 BLC projects of State Government of Kerala against which the above assistance towards balance amount of 1st instalment of the Central Assistance stands sanctioned is annexed.
- 3. The sanction is based on the approval and recommendation of CSMC of MoHUPA under Pradhan Mantri Awas Yojana (Urban) in its **18**th meeting held on 18.01.2017. The amount of central assistance is being released subject to the following conditions:
 - i. Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
 - ii. The State Government and implementing agencies shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
 - iii. The State Govt./implementing agencies shall utilize the assistance in accordance with the approved guidelines for the implementation of the Scheme of PMAY (U).
- iv. The State Govt./ULB shall provide funds as per approvals in the projects.
- v. The State Government shall furnish Utilization certificates of the Assistance released in the prescribed format (form 19-A) as per GFR 2017 and as provided in the scheme guidelines.
- vi. The funds shall be utilized for the purpose for which these are sanctioned; otherwise these will have to be refunded along with interest as per provisions for GFR-2017.
- vii. Transfer of funds to different entities and individual beneficiaries shall be made through PFMS/DBT, as applicable.
- 4. The sanctioned fund may be released to the State Government immediately. The fund may thereafter be released to the implementing agencies by the State Government without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.

5. The payment is debitable from the account of the Central Government in the books under the following Head of Account under Demand No. 56 of M/o Housing and Urban Poverty Alleviation for the year 2017-18:
