 - (v) State Government of **Meghalaya** is required to furnish Utilisation Certificate as per GFR and Statement of Expenditure to the Government of India before claiming next installment on utilisation of 70% of the amount released earlier for preparation of SFCPoA and the instant release for preparation of HFAPoA.
 - (vi) The amount of central assistance approved will form a part of capacity building plan of the State under PMAY-HFA (Urban) mission.

- (vii) The Grant sanctioned will be utilized for the purpose for which it is released. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work and furnish physical and financial progress reports (every quarter).
- (viii) Where there is an element of cash transfer, the same may be made through PFMS/DBT mode as applicable.
