Sub: **Release of Rs. 193.725 Lakhs as 1st installment of central assistance to the Government of Himachal Pradesh for preparation of HFAPoA in 41 additional cities/towns included under PMAY-HFA (U) Mission.**

Sir,

I am directed to convey the sanction of the President of India to the amount of **Rs. 1,93,72,500/- (Rupees One Crore Ninety-three Lakh Seventy-two Thousand and Five Hundred only)** as 1st installment (75% of Central Share) to the State Government of **Himachal Pradesh** for preparation of Housing for All Plan of Action (HFAPoA) in 41 cities/towns recently included under the PMAY-HFA (U) Mission. The list of additional 41 towns/cities for which 1st installment is being released is at Annexure. The amount being released is 75% of the approved Central assistance computed on the basis of financial norms finalized in the 1st meeting of CSMC under PMAY (U) held on 17.09.2015.

2. The above grant is subject to the following conditions:

- i. The above release is only for those cities which are approved by this Ministry under PMAY (U) Mission, as per the list at Annexure.
- ii. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- iii. The State will utilize the sanctioned grant for the purpose for which it is released. The State Government/Nodal Agency shall furnish physical and financial progress reports every quarter.
- iv. State/cities to which assistance under RAY for preparation of SFPCoA have earlier been released, should fully utilize that amount for preparation of HFAPoA, if the same city has been included under PMAY (U) Mission.
- v. State Government is required to furnish UC as per GFR and Statement of Expenditure to the Government of India before claiming next installment on utilization of 70% of the amount released earlier for preparation of SFPCoA and the instant release for preparation for HFAPoA.
- vi. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- vii. The amount of central assistance approved will form a part of capacity building plan of the State under PMAY-HFA (Urban) Mission.
- viii. Transfer of funds to different entities may be made through PFMS, as applicable; and where there is an element of case transfers to individual beneficiaries, the same may be made through DBT mode, as applicable.
