The undersigned is directed to convey the Sanction of the President of India to the payment as part of 1<sup>st</sup> installment amounting to Rs. 27,44,16,000/- (Rupees Twenty Seven Crore Forty Four Lakh and Sixteen Thousand only) to the State Government of Gujarat being Central Assistance (Grant) for Capital Creation under PMAY- Housing for All (Urban) mission for State's Annual Plan 2015-2016.

- 3. Based on decision of CSMC in its 3<sup>rd</sup> meeting held on 18<sup>th</sup> November, 2015 and on the recommendations made by MoHUPA, the amount of central assistance is being released subject to adhering to the following conditions:
- (i) Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
- (ii) The States Government and implementing agency shall put in place a monitoring system to ensure that the project (s) achieve its scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- (iii) Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme.
- (iv) Provide the State Share as per PMAY- HFA (Urban) Mission Guidelines.
- (v) Furnish the Utilization certificates of the Grant released for the PMAY-HFA (Urban) in the prescribed format as per GFR 2005.
- (vi) The funds may be utilized for the purpose for which they are given. Otherwise they will have to be refunded along with interest as per provisions for GFR-2005.
- 4. In addition to the above, State Govt. of Gujarat will also comply with the following observations of CSMC on the projects:
  - (i) List of beneficiaries should be finalized along with their social and other categories before release of 2<sup>nd</sup> installment. Beneficiaries should be identified as per Mission Guidelines with adherence to all categories and
  - (ii) State and ULB need to ensure availability of infrastructure and deploy disaster resistant features in implementing these projects.
- 5. Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
