Sub: **Release of Rs.31,50,000/ as central assistance to the UT Government of Puducherry for preparation of Housing for All Plan of Action (HFAPoA).**

Sir,

The undersigned is directed to convey the sanction of the President of India to the amount of **Rs. 31,50,000/- (Rs. Thirty one lakh fifty thousand only)** as 1<sup>st</sup> installment to the **UT Government of Puducherry** for preparation of HFAPoA. A list of towns/cities for which first installment is being released is enclosed at Annexure 1.

2. The above grant is subject to the following conditions:
- i. The above release is first instalment of grants approved as per the financial norms approved by 1<sup>st</sup> CSMC under HFA held on 17<sup>th</sup> September 2015. The UT Government will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
  - ii. The above release is only for those cities which are approved by this Ministry under HFA mission.
  - iii. The UT Government/cities to which assistance under RAY for preparation of SFCPoA have been given, should utilize that amount for preparation of HFAPoA and claim next instalment when 70% of the released funds have been utilized for these cities.
  - iv. The Grant sanctioned will be utilized for the purpose for which it is released. The UT Government/Nodal Agency shall furnish physical and financial progress reports (every quarter).
  - v. The UT Government of **Puducherry** is required to furnish Utilization Certificate as per GFR and Statement of Expenditure to the Government of India as soon as the fund utilization exceeds 70% of the amount released.
  - vi. The UT Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
  - vii. The amount of central assistance approved will form a part of capacity building plan of the UT Govt under PMAY-HFA(Urban) Mission.
  - viii. Transfer of funds to different entities/individuals shall be made through PFMS/DBT mode, as applicable.


5. This being the first installment of the grant under PMAY (U) for preparation of HFAPoA, no UC is pending from the UT Government of Puducherry.


