State Government of **Meghalaya** is required to furnish Utilisation Certificate as per GFR and Statement of Expenditure to the Government of India before claiming next instalment on utilisation of 70% of the amount released earlier for preparation of SFCPoA and the instant release for prerparation of HFAPoA.
- Viv. The amount of central assistance approved will form a part of capacity building plan of the State under PMAY-HFA (Urban) mission.
