Sir,

The undersigned is directed to convey the Sanction of the President of India to the release of Rs. 36,27,43,000/- (Rupees Thirty Six Crore Twenty Seven Lakh and Fourty Three Thousand only) to the State Government of **Rajasthan** as a Central Grant for Creation of Capital Assets under Pradhan Mantri Awas Yojana (PMAY)- Housing for All (Urban) Mission under Plan Allocation for Year 2015-2016.

3. Release of Central Assistance is also subject to adhering to the following conditions:

- (i) Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
- (ii) The States Government /Cities and Implementing Agencies shall put in place a monitoring system to ensure that the project (s) achieve its scheduled milestone and envisaged outcomes including implementation of Mandatory Conditions and other conditionalities required under the scheme.
- (iii) Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme.
- (iv) Provide the State Share as per PMAY - HFA (Urban) Mission Guidelines.
- (v) Furnish the Utilization Certificates of the Grant released for the PMAY - HFA (Urban) Mission in the prescribed format as per GFR – 2005 and in accordance with the Mission Guidelines.
- (vi) The funds may be utilized for the purpose for which they are given. Otherwise they will have to be refunded along with interest as per provisions for GFR-2005.
- (vii) Where there is an element of cash transfers to individual beneficiaries, the same may be made through DBT mode.

4. In addition, the State Government of Rajasthan will comply with the following observations of CSMC:-

- (i) List of beneficiaries should be finalized along with their social and other categories before release of 2<sup>nd</sup> installment. Beneficiary should be identified as per Mission Guidelines with the adherence to all categories.
- (ii) State and ULB need to ensure availability of infrastructure and deploy disaster resistant features in implementing these projects.

5. Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.

6. The payments are adjustable in the account of the Central Government in the books under the following Head of Account under Demand No. 58 (Plan) of M/o Housing and Urban Poverty Alleviation for the year 2015-16:

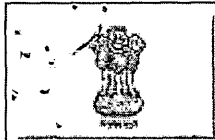
