- (vi) UT administration will be required to certify that the specifications of the houses conform to NBC Standards and that requisite infrastructure will be provided by the State Government/ULB.



- 4. Payment may kindly be made to the U.T. administration of Dadra & Nagar Haveli immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the U.T. administration with interest for the period of default.
