- iii. The State will utilize the sanctioned grant for the purpose for which it is released. The State Government/Nodal Agency shall furnish physical and financial progress reports every quarter.
- iv. Further installment of funds will be considered on receipt of expenditure statement/UC from the State Government along with details of specialists engaged subject to financial norms approved by CSMC in its 1st meeting under PMAY (U) as well as adherence to scheme guidelines, furnishing clarifications/supporting documents/qualification of specialists and submission of pending UCs under RAY, if any.

- vi. State Government is required to furnish Utilization Certificate as per GFR and Statement of Expenditure to the Government of India before claiming next installment on utilization of 70% of the amount released earlier.
- vii. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- viii. The amount of central assistance approved will form a part of capacity building plan of the State under PMAY(Urban) -HFA mission.

  The State Government/Nodal Agency shall transfer of funds to the entities/individual through PFMS/DBT mode as applicable.
