- vii. State Government will be required to certify that the specifications of the houses conform to NBC Standards and that requisite infrastructure will be provided by the State Government/ULB.
- viii. The State must mandatorily ensure data entry in PMAY-MIS and geo-tagging of photographs to monitor progress of the house construction before release of each installment to beneficiaries.
 - ix. The State to ensure the occupancy of houses under JNNURM and construction of houses sanctioned under RAY.
