- iii. State/cities to which assistance under RAY for preparation of SFCPoA have been given, should utilize the amount for preparation of HFAPoA and claim next installment when 70% of the released funds have been utilized for these cities.
- iv. The Grant sanctioned will be utilized for the purpose for which it is released. The State Government/Nodal agency shall furnish physical and financial progress reports (every quarter).
- v. State Government of Jharkhand is required to furnish Utilization Certificate as per GFR and Statement of Expenditure to the Government of India as soon as the fund utilization exceeds 70% of the amount released.
- vi. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work:
- vii. The amount of central assistance approved will form a part of capacity building plan of State under PMAY (Urban)-HFA Mission.
- viii. Transfer of funds to different entities/individuals shall be made through PFMS/DBT mode, as applicable.
