 - The State Govt./ULB shall provide funds as per approvals in the projects. xi.
 - The State Government shall furnish Utilization certificates of the Grant released in the prescribed format (form 19-A) as per GFR - 2017 and as provided in the scheme xii. guidelines.
- The funds shall be utilized for the purpose for which these are sanctioned; otherwise these will have to be refunded along with interest as per provisions for GFR-2017. xiii.
- Transfers of funds to different entities and individual beneficiaries shall be made xiv. through PFMS/DBT, as applicable.
- Release of the Grant may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
