- viii. The State must mandatorily ensure data entry in PMAY-MIS and geo-tagging of photographs to monitor progress of the house construction before release of each installment to beneficiaries.
 - ix. The State to ensure the occupancy of houses under JNNURM and construction of houses sanctioned under RAY. Eralant

- Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
