Sir,

I am directed to convey the sanction of the Competent Authority to release an amount of **Rs. 36,43,000/- (Rupees Thirty Six Lakh and Forty Three Thousand only)** to the State of **Meghalaya** as balance payment of 1st instalment of Rs. 56.43 lakh of Central Assistance for establishment of 1 State Level Technical Cell (SLTC) and 3 City Level Technical Cells (CLTCs) for the year 2016-17 under Pradhan Mantri Awas Yojana - Housing For All (Urban) Mission. Details are as under and also enclosed at **Annexure I & II:**

2. The above grant is subject to the following conditions:

- i. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- ii. The State is requested to establish the SLTC and CLTCs at the earliest under intimation to this Ministry.
- iii. The State will utilize the sanctioned grant for the purpose for which it is released. The State Government/Nodal Agency shall furnish physical and financial progress reports every quarter.
- iv. Further installment of funds will be considered subject to ratification of the approval of the SLSMC of the proposal submitted by Govt. of **Meghalaya** and on receipt of expenditure statement/UC from the State Government along with details of specialists engaged subject to financial norms approved by 1st CSMC as well as adherence to scheme guidelines and submission of pending UCs under RAY, if any.
- v. If the existing Cell under RAY has been continued for PMAY (U) mission, the funds will be considered for release on receipt of expenditure statement and submission of pending UCs under RAY, if any,.
- vi. State Government is required to furnish Utilization Certificate as per GFR and Statement of Expenditure to the Government of India before claiming next installment on utilization of 70% of the amount released earlier.

- vii. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- viii. The amount of central assistance approved will form a part of capacity building plan of the State under PMAY-HFA (Urban) mission.
- ix. Transfer of fund to different entities/individuals shall be made through PFMS/DBT mode, as applicable.
