- State Governments are required to furnish Utilization Certificate as per GFR and Vİ. Statement of Expenditure to the Government of India before claiming next installment on utilization of 70% of the amount released earlier.
- VII. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- The amount of central assistance approved will form a part of capacity building VIII. plan of the State under PMAY (U) mission.
