

Sir/Madam,

I am directed to convey the sanction of the President of India to the amount of **Rs. 1,50,67,315/- (Rupees One Crore Fifty Lakh Sixty-seven Thousand Three Hundred and Fifteen only)** as 1<sup>st</sup> installment (50% of Central Share) towards establishment of State Level Technical Cell and City Level Technical Cells (CLTC) in the State of Himachal Pradesh under PMAY (U) Mission. The statement showing details of the SLTC/CLTCs is as under:

2. The above grant is subject to the following conditions:

- (i) The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- (ii) Financial norms approved by 1<sup>st</sup> CSMC as well as adherence to scheme guidelines and submission of pending UCs under RAY, if any.
- (iii) The State will utilize the sanctioned grant for the purpose for which it is released. The State Government/Nodal Agency shall furnish expenditure statement alongwith physical and financial progress reports on quarterly basis. State should also submit the positioning status of experts engaged under SLTC/CLTCs for the FY 2017-18.
- (iv) 2<sup>nd</sup> installment of funds will be considered on receipt of expenditure statement / UC from the State Government along with details of specialists engaged under

PMAY (U) Mission as per financial norms, ToRs and methodology for SLTCs & CLTCs issued vide Ministry's letter no. N-11011/30/2015-HFA-2 (Part)/FTS-13652 dated 24.09.2015 as well as other instructions issued from time to time. If the State has continued the existing Cell under RAY for PMAY (U) Mission, the funds will be considered for release on receipt of expenditure statement and submission of pending UCs under RAY, if any.

- (v) State Government are required to furnish Utilization Certificate as per GFR-2017 and Statement of Expenditure to the Government of India before claiming next installment on utilization of 70% of the amount released earlier.
- (vi) The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- (vii) The amount of central assistance approved will form a part of capacity building plan of the State under PMAY-HFA (Urban) mission.
- (viii) Transfer of funds to different entities may be made through PFMS, as applicable; and where there is an element of cash transfers to individual beneficiaries, the same may be made through PFMS/DBT mode, as applicable.

3. The amount is debitible from the account of the Central Government in the books under the following Head of Account under Demand No. 56 M/o Housing and Urban Poverty Alleviation for the year 2017-18:

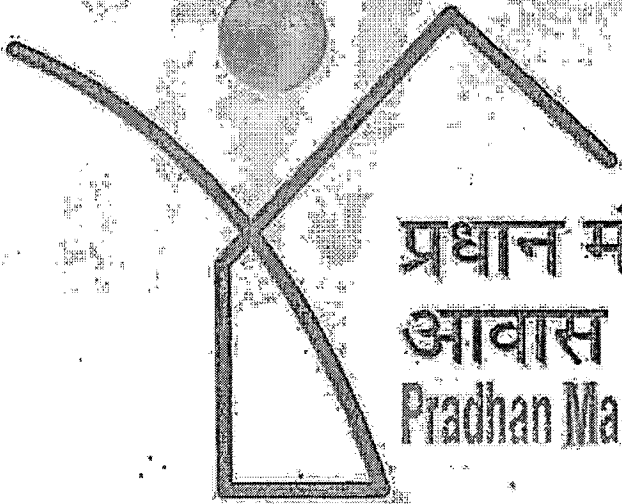
