- vi. Where there is an element of cash transfer to individual beneficiaries, the same may be made through PFMS/DBT mode as applicable.

- vii. UT Government will be required to certify that the specifications of the houses conform to NBC Standards and that requisite infrastructure will be provided by the UT Government/ULB.
- 4. Payment may kindly be made to the UT Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the UT Government with interest for the period of default.
