Sub: **Release of Rs. 268.80 Lakh to the UT Govt. of Puducherry for 4 BLC (New Construction) projects under PMAY-HFA(U) Mission - reg.**

Sir,

I am directed to convey the sanction of the President of India to the release of **Rs. 2,68,80,000/- (Rupees Two Crore Sixty Eight Lakh and Eighty Thousand only)** to the **UT Govt. of Puducherry** as 1<sup>st</sup> installment (40% of Central Assistance) for Creation of Capital Assets for 4 BLC (New Construction) projects for Karaikal and Puducherry Cities under Pradhan Mantri Awas Yojana - Housing for All (Urban) Mission for the FY 2017-2018.

2. The statement showing details of the project towards 1<sup>st</sup> installment of the Central Assistance is at **Annexure**.

3. Based on decision of CSMC under PMAY - HFA (Urban) Mission in its **31<sup>st</sup> meeting held on 27<sup>th</sup> February 2018**, the amount of Central Assistance is being released subject to the following conditions:

- i. Necessary sanctions/approvals/compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority(ies) concerned with the project(s).
- ii. The UT Government and implementing agency shall put in place a monitoring system to ensure that the project(s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- iii. The UT Government shall utilize the grant in accordance with the approved guidelines for the implementation of the Scheme of PMAY - HFA (Urban) Mission.
- iv. The UT Government shall furnish the Utilization certificates of the Grant released in the prescribed format as per GFR 2017 as provided in the scheme guidelines.
- v. The funds may be utilized for the purpose for which these are given. Otherwise these will have to be refunded along with interest as per provisions under GFR 2017.
- vi. Where there is an element of cash transfer to individual beneficiaries, the same may be made through PFMS/DBT mode as applicable. The UT Govt. shall submit an authenticated certificate from the bank showing complete details of disbursement of funds to each beneficiary before release 2<sup>nd</sup> instalment.

vii. The UT Government will be required to certify that the specifications of the houses conform to NBC Standards and that requisite infrastructure will be provided by the UT Government/ULB.

viii. The UT Govt. shall submit the report of Third Party Quality Monitoring Agency (TPQMA) selected by UT for quality monitoring purpose before release of 2<sup>nd</sup> instalment.

4. Payment may kindly be made to the UT Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the UT Government with interest for the period of default.

5. The expenditure involved is debitible to the following Head of Account under Demand No. 56 of Ministry of Housing and Urban Poverty Alleviation for the year 2017-18:
