- The States/UTs will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- The States/UTs will utilize the sanctioned grant for the purpose for which it is released.

- (iii) 2nd installment will be released on the basis of actual accepted geotagging points on Bhuwan portal for each project for which funds have been released. There are 5 stages available on Bhuwan portal for which beneficiaries can be geotagged including completion stage. Before release of 2nd installment the completion stage of all beneficiaries in a project must be done.
- (iv) 2nd installment would be released to the State/UT as per actual and on receipt of Utilization Certificate along with undertaking/Certificate on Geo-Tagging Expenses (in prescribed format mentioned in Capacity Building Activities – Norms, fund Disbursal processes and Plan Templates).
- (v) The State/UT Governments/Nodal Agency will strictly monitor the progress of the preparatory work.
- (vi) The amount of central assistance approved will form a part of capacity building plan of the States/UTs under PMAY (Urban) mission.
- (vii) Transfer of funds to different entities may be made through PFMS, as applicable; and where there is an element of cash transfers to individuals, the same may be made through PFMS/DBT mode, as applicable.

4. The expenditure involved is debit to the following Head of Account under Demand No. 56 of M/o Housing and Urban Affairs for the year 2018-19 from the following Head:



8. The sanction has been registered at **Sl. No. 280** of the Grants-in-Aid Register of the HFA Division for the year 2018-19.


