Sub: 1st installment of Central assistance for Geo-Tagging Activities performed by the State of Sikkim under BLC component of PMAY (U) - reg.

Sir/Madam,

I am directed to convey the sanction of the President of India to the release of **Rs. 28,400/- (Rupees Twenty-Eight Thousand and Four Hundred only)** as 1st installment (50% of Central Share) towards Geo-tagging activities performed by the **State of Sikkim** under BLC component of PMAY (U). The statement showing project-wise details of geo-tagging and amount admissible are annexed.

2. The above grant is subject to the following conditions:

- The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- The State will utilize the sanctioned grant for the purpose for which it is released.
- 2nd installment will be released on the basis of actual accepted geotagging points on Bhuvan portal for each project for which funds have been released. There are 5 stages available on Bhuvan portal for which beneficiaries can be geotagged including completion stage. Before release of 2nd installment the completion stage of all houses in a project must be done.
- The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- The amount of central assistance approved will form a part of capacity building plan of the State under PMAY (Urban) mission.
- Transfer of funds to different entities may be made through PFMS, as applicable; and where there is an element of cash transfers to individual beneficiaries, the same may be made through PFMS/DBT mode, as applicable.

3. The amount is debitible from the account of the Central Government in the books under the following Head of Account under Demand No. 56 Ministry of Housing and Urban Affairs for the year 2018-19:





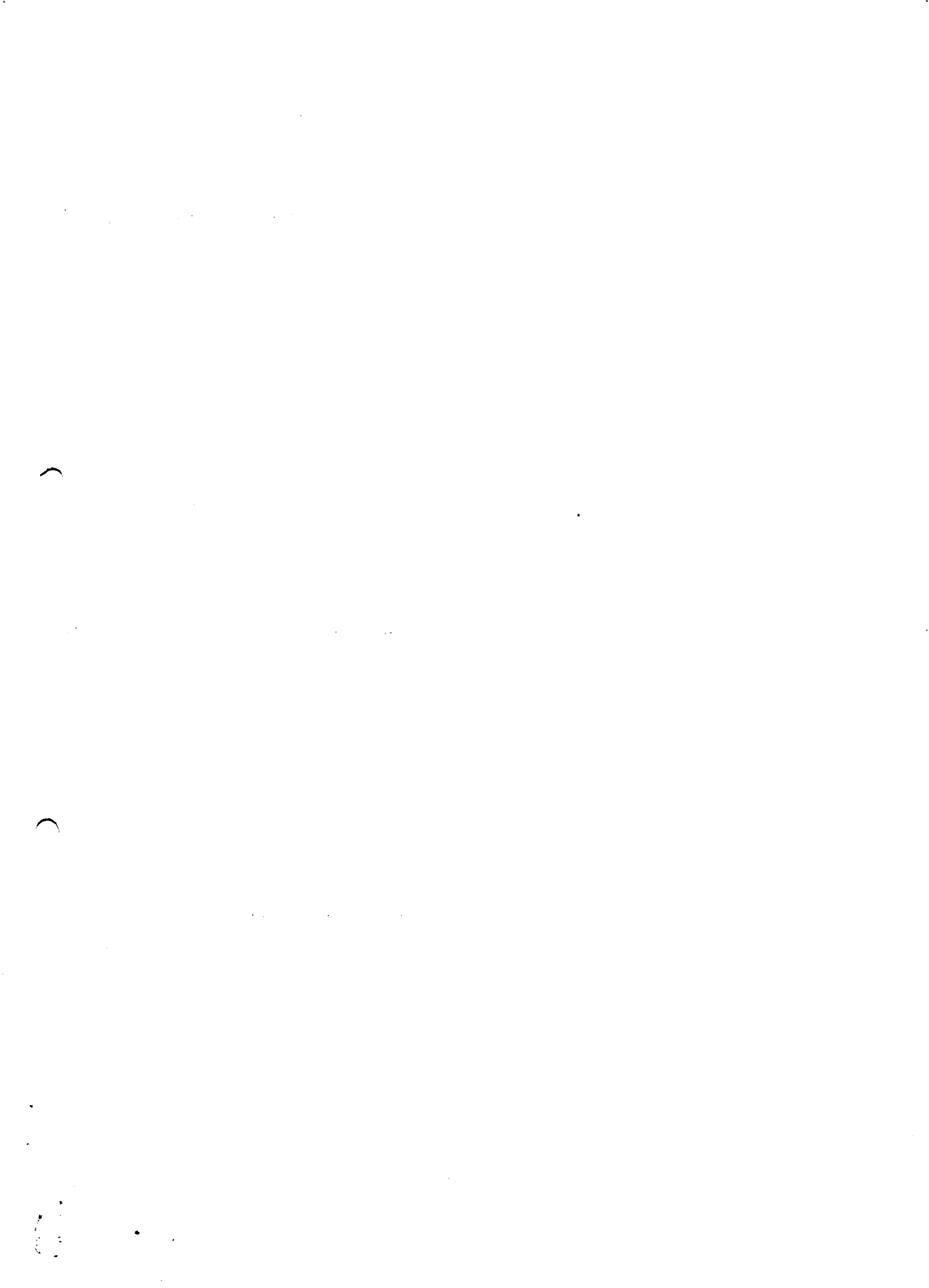
