Sub: Release of advance of interest subsidy to National Housing Bank (NHB) under CLSS for EWS/LIG component of PMAY (U).

Sir,

I am directed to convey the sanction of the President of India for release of ₹490,00,00,000/- (Rupees four hundred ninety crore only) as advance of interest subsidy to National Housing Bank (NHB) being the Central Nodal Agency for implementation of Credit Linked Subsidy Scheme for Economically Weaker Section/Low Income Group (CLSS for EWS/LIG) component of Pradhan Mantri Awas Yojana - Housing for All (Urban) Mission for making direct release to the Primary Lending Institutions (PLIs) which have signed MoUs with NHB under the scheme, based on the claims submitted by PLIs towards the loans disbursed as per the scheme.

- 2. The release of funds to CNA is further subject to the following terms and conditions:-
- The release made by MoHUA shall be kept in a separate designated account for utilization towards the implementation of the scheme and shall not form part of their general financial operations.
- The money will be utilised only for the purpose for which it has been sanctioned and the interest accrued from the advance released will be credited in the same account of CLSS for EWS/LIG.
- iii. CNA will exercise requisite checks and due diligence in settlement of claims.
- CNA will obtain required data and documents from the respective PLI and furnish a utilization certificate towards the release made as soon as possible.
- The subsequent amounts of interest subsidy will be released to CNA after 70% utilization of earlier released amounts, on quarterly basis, and based on claims raised by CNA in the prescribed format (Annexure 3 of the scheme guidelines).
- PLIs will be given a lump sum amount of ₹3,000/- per sanctioned application in lieu of processing fee for housing loan for the borrower under the scheme. A sum of ₹250/- per sanctioned application would be paid out of scheme funds to the designated staff of ULBs or NGOs or the local agencies identified by the State/ULBs for facilitating the applications from intended beneficiaries.
- 0.1 % of total fund disbursement to the PLIs will be paid to CNA for their vii. administrative expenses for which CNA will furnish the details to MoHUA.

- viii. CNA will submit progress reports including the details of expenditure to MoHUA regularly in the prescribed formats.
- ix. Where there is an element of cash transfer the same may be made through PFMS/DBT mode as applicable.
- x. NHB to ensure compliance as stated in NHB letter dated 27 October 2022 that there is electronic evidence/trail for the claims of CLSS subsidy towards homeloan sanctioned and disbursed by PLIs upto 31 March,2022 which are being processed by CNAs on the basis of claims uploaded by PLIs on CNAs portal up to 30 June 2022 and also that there is documentary evidence that the application for CLSS subsidy by the beneficiaries were received by 31 March, 2022 by the PLI.
- xi. CNA to ensure compliance of the conditions enumerated in O.M. No.3/(32)/PFMS/2022 dated 30-11-2022 (copy enclosed) from Department of Expenditure, Ministry of Finance.
- 3. In pursuance to DEA ID Note No. 7/4/2020-BA (Pt.) dated 10-11-2022 conveying authorization for incurring excess expenditure of ₹5,500 crore under CLSS(EWS/LIG) component of PMAY-U by invoking Appendix-10 under Rule 61 and 69 of GFR 2017, the expenditure involved will be debited from Head 2216.02.502.01.01.33 (Subsidy) under Demand No. 60 of Ministry of Housing & Urban Affairs for the year 2022-23 and will be transferred to the following head of account after obtaining necessary supplementary demand in 1st SDG for FY 2022-23.

## **OFFICE MEMORANDUM**

Subject: Procedure for release of funds under the Centrally Sponsored Schemes – relaxation sought by Ministry of Housing and Urban Affairs regarding Credit Linked Subsidy Scheme (CLSS) vertical (EWS/LIG) of PMAY – Urban.

The undersigned is directed to refer to the Secretary, MoHUA, DO letter No. G-28011/17/2017-HFA IV dated November 18, 2022 on the above mentioned subject. The matter was discussed with the officers of MoHUA on 29<sup>th</sup> November, 2022.

- 2. The matter has been examined further in this Department and the request of MoHUA to grant exemption to CLSS from the provisions of DoE's guidelines dated 9<sup>th</sup> March, 2022 is agreed to till 31/3/2023 subject to the following conditions
  - i. The three Central Nodal Agencies (CNAs) of the scheme will be onboarded on PFMS.
  - ii. Funds will be credited to the end beneficiaries within a period of 7 days of release of funds by MoHUA to the CNA.
- iii. Interest accrued by the CLSS funds in the respective CNA accounts will be deposited back to the Consolidated Fund of India (CFI).
- iv. MoHUA will regularly track the date of credit of funds to end beneficiaries through CLSS AWAS Portal (CLAP).
- v. In case of any delay in crediting funds to end beneficiaries beyond 7 days of receipt of funds by a Central Nodal Agency, a penal interest on the number of days of delay shall be levied on the CNA. The rate of penal interest will be the effective rate on market borrowing/State Development Loans (SDL) during the period of delay. MoHUA will ensure that the penal interest is deposited in the CFI.
