Sub: Release of advance subsidy of Rs.600,00,00,000/- (Rupees Six Hundred Crore only) from Extra Budgetary Resources (EBR) borrowed from National Small Savings Fund (NSSF) to State Bank of India (SBI) under Credit Linked Subsidy Scheme for Middle Income Group (CLSS for MIG) component of Pradhan Mantri Awas Yojana – Housing for All (Urban) Mission.

Sir.

Pursuant to the constitution of National Urban Housing Fund (NUHF) in BMTPC for channelizing central assistance/subsidy under the PMAY(U), I am directed to convey the sanction of the competent authority and authorize BMTPC for release of advance subsidy of Rs.600,00,00,000/- (Rupees Six Hundred Crore only) from EBR fund borrowed from National Small Savings Fund (NSSF) to State Bank of India(SBI) Corporate Office, Mumbai being the Central Nodal Agency for implementation of Credit Linked Subsidy Scheme (CLSS) for Middle Income Group (CLSS for MIG) component of Pradhan Mantri Awas Yojana – Housing for All (Urban) Mission for making direct release to the Primary Lending Institutions (PLIs) which have signed MoUs with SBI under the scheme, based on the claims submitted by PLIs towards the loans disbursed as per the scheme.

- The release of Rs.600,00,00,000/- (Rupees Six Hundred Crore only) is further subject to the following terms and conditions:-
 - BMTPC shall release the amount to SBI, Corporate Office, Mumbai within two working days through EAT module of PFMS route.
 - II. BMTPC shall maintain proper record of the release in the NUHF set up in a prudent manner as per financial rules.
- III. The release made by BMTPC shall be kept in a separate designated account for utilization towards the implementation of the scheme and shall not form part of their general financial operations.
- IV. SBI shall utilize the money only for the purpose for which it has been sanctioned and the interest accrued from the advance released will be credited in the same account of CLSS.
- V. SBI will exercise requisite checks and due diligence in settlement of claims.
- VI. SBI will obtain required data and documents from the respective PLI and furnish a utilization certificate towards the release made as soon as possible.
- VII. The subsequent amounts of interest subsidy will be released to SBI after 70% utilization of earlier released amounts, on quarterly basis, and based on claims raised by SBI in the prescribed format (Annexure 3 of the scheme guidelines).
- VIII. PLIs will be given a lump sum amount of Rs.2,000/- per sanctioned application in lieu of processing fee for housing loan for the borrower under the scheme.
- IX. 0.1 % of total fund disbursement to the PLIs will be paid to SBI for their administrative expenses for which SBI will furnish the details to M/o HUA.
- X. SBI will submit progress reports including the details of expenditure to M/o HUA regularly in the prescribed formats.
- XI. BMTPC shall adhere to the conditions stipulated in the letter F. No 5/7/2019-NS(Pt.) dated 19.09.2019 issued by Ministry of Finance in respect of EBR raised through NSSF.

3. The expenditure is to be booked in PFMS scheme code 3186-EBR for advance interest subsidy under CLSS MIG category for the financial year 2019-20 and will be transferred to SBI through e-payment as per the details as under:-

- 4. The utilization certificate has to be provided to BMTPC and this Ministry in the prescribed format and timeline as per the provisions of GFR.
- 5. As per rule 236(1) of GFR, 2017, the relevant accounts of the Grantee institution (s) / Organisation(s) shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.
- This issues with the concurrence of the Finance Division vide their Note# 10 dated-14.12.2019.

This is with reference to the letters No. REHBU/PMAY/PP/1597/18-19 dated 7th March, 2019 and REHBU/PMAY/460 dated 23rd July, 2019 from your Office on the subject mentioned above.

- 2. State Bank of India (SBI) has approached this Ministry to nominate their Bank as Central Nodal Agency (CNA) under the provisions of Para 5.4 of the Pradhan Mantri Awas Yojana (Urban) {PMAY (U)} Mission guidelines, vide their letters mentioned above. Therefore, the matter has been considered in this Ministry and it has been decided that SBI may be nominated as CNA under the above said provisions of the PMAY (U) guidelines.
- 3. It has further been decided that SBI Corporate Centre, Mumbai will act as CNA for SBI Bank branches only. As regards signing of Memorandum of Understanding (MoU) between CNA and the Primary Lending Institutions (PLIs) under Para 5.5 of the PMAY(U) guidelines, it has been decided that the SBI Corporate Centre, Mumbai will sign the MoUs, with their 17 Local Head Offices (LHOs) for and on behalf of the branches under their administrative control.
