- i. The systematic 3 layer beneficiary selection process of verifying the Aadhar-based beneficiary data in application firstly with SECC data, secondly through Household survey and thirdly by taking photographs may be effective and helpful for geo-tagging and tracking progress during implementation.
- ii. The State should complete demand assessment in 2 months, as stated, and come up with more proposals immediately.
- iii. The State should share soft copies of the beneficiary list for CLSS component with HUDCO/NHB.
- iv. Disaster-resilience for the proposed models for beneficiary-led construction must be ensured by the State.
- v. BMTPC was asked to handhold the State in preparing the design and working drawings for actual construction to take care of all types of disasters including earthquake.
- vi. The State should communicate to the Ministry about the status and timeline of completing implementation of all the mandatory reforms by December, 2016. As regards Mandatory Reforms, which are not applicable in the State, as mentioned by the representative of the State, a written communication from the State government is required.
- vii. UCs pending to the tune of Rs. 30.06 cr in respect of JNNURM projects are to be submitted soon.

#### **D. CSMC Decisions:**

In view of the above, the CSMC:

- (i) accorded approval for Central Assistance amounting to Rs. 46.35 Crore for the 4 Projects under BLC (New Construction) for construction of 3,090 houses of EWS category as proposed by the State Government of Manipur under PMAY (Urban) as per details at **Annexure II**
- (ii) recommended for release of the first instalment of Central Assistance amounting to Rs. 18.54 Crore (40% of Central Assistance) for 4 BLC(New Construction) projects.

#### B. Additional information by the State:

- i. Out of the excess ACA of Rs. 75.64 Cr pertaining to JNNURM projects, the recoverable amount of Rs. 33.49 Cr would be returned to Government of India on 3<sup>rd</sup> November, 2016; and the remaining recoverable amount will be returned by 15<sup>th</sup> November, 2016.
- ii. With respect to unoccupied Dwelling Units from JNNURM projects, new beneficiaries are being selected and the DUs will be occupied within three months.

- iii. The State Government's proposal to take up greenfield housing project by tying up the bank loan for beneficiaries under CLSS could not be taken up since the banks are insisting on margin money. The State Government may alternatively consider taking up these projects under AHP.

- i. The verification of the land titles of the verified/selected beneficiaries has to be completed by the State at the earliest.
- ii. The recoverable ACA are to be refunded within the period committed to by the State Government.

In view of the above, the CSMC:

- (i) accorded approval for Central Assistance amounting to Rs. 197.055 Crore for the 78 Projects under BLC (New Construction) for construction of 13,137 houses in EWS category submitted by the State Government of Punjab under PMAY(Urban) as per Annexure III-A
- (ii) accorded approval for Central Assistance amounting to Rs. 19.99 Crore for the 73 Projects under BLC (Enhancement) for construction of 2,072 houses in EWS category submitted by the State Government of Punjab under PMAY(Urban) as per **Annexure III-B**
- (iii) recommended release of the first instalment of Central Assistance amounting to Rs. 78.822 Crore (40% of Central Assistance) for the 78 BLC (New Construction) projects, subject to compliance to CSMC's observation at paras 6(C)(i) & (ii) respectively.
- (iv) recommended release of the first instalment of Central Assistance amounting to Rs. 7.9943 Crore (40% of Central Assistance) for the 73 BLC (Enhancement) projects, subject to compliance to CSMC's observation at paras 6(C)(i) & (ii) respectively.

Proposal for recruitment of additional/extra experts in CLTCs submitted by PUNJAB

#### A. **Brief**:

- (i) Agenda Note highlighting important aspects of Annual Capacity Building Plan (2016-17) of the Government of Punjab is at **Annexure IV**.
- (ii) CSMC was apprised that the Government of Punjab in their Annual Capacity Building Plan (2016-17) has proposed to hire 01 extra personnel in each of the 02 individual



- CLTCs (Amritsar and Ludhiana), having population more than 10 lakhs. The State has also proposed to hire 01 extra personnel in the individual CLTC at Jalandhar, having population between 5 to 10 lakhs.
- (iii) It was informed that consideration / approval of CSMC on this proposal is required in terms of Para 12.14 of the PMAY (U)-HFA Mission Guidelines.
- (iv) The proposal of the State is justified in case of Amritsar and Ludhiana since it meets the population criteria, while the proposal for including extra manpower in case of individual CLTC at Jalandhar is not justified, since the population is less than 10 lakhs.

#### B. **CSMC Decision:**

In view of the above, the CSMC:

- (i) took note and ratified the composite proposal relating to the Annual Capacity Building Plan (2016-17) of the Government of Punjab, and also ratified the release of funds for SLTC to State Government of Punjab.
- (ii) approved the proposal of the State Government of Punjab for hiring 01 extra personnel in each of the 02 individual CLTCs of Amritsar and Ludhiana;.
- (iii) recommended release of 1<sup>st</sup> installment (50% of the appraised Central Share) amounting to Rs. 117.90 lakhs to the State Government of Punjab for establishing the CLTCs as proposed.

- i. Housing for All Plan of Action has been completed for 118 cities. The demand of houses in
- i. these 118 cites is 10,13,029. Demand survey is complete in all cities (except large municipal corporations/ newly constituted municipalities).
- ii. All institutional arrangements as required have been put into place. A series of workshops has been organised with cities for sensitization and adherence to deadlines for different activities prescribed by Government of India.
- iii. Out of 47,050 EWS houses sanctioned in 70 BLC projects (1<sup>st</sup> phase), on-line data entry is complete for 39,318 beneficiaries (84%), and 25,021 beneficiaries' details have been attached to the projects. Construction of 19,171 houses is in progress and construction of 526 houses have been completed.
- iv. Engineers of the ULBs and Municipal Engineering Directorate (MED) are providing technical assistance to the beneficiaries in constructing their houses.
- v. Out of 27,380 EWS houses sanctioned in 38 BLC projects (2<sup>nd</sup> phase), on-line data entry is complete for 19,887 beneficiaries (71%). The construction of houses will be started by December 2016.
- vi. Geo-tagging has been started in 17 ULBs.
- vii. The model building plan, approved by the MED may be revised as per the availability of land with the beneficiaries. Revision would be done after the approval of competent technical authority of the ULB/MED ensuring NBC norms.
- viii. Most of the mandatory reforms have been achieved by the State except the reform related to Non-Agricultural permission. State government will send a communication about updated position in this regard.

- (ii) recommended release of the first instalment of Central Assistance amounting to Rs. 284.274 Crore (40% of Central Assistance) for the 28 BLC projects for the 47,379 houses.

#### B. Additional information by the State:

- i. The Demand survey for all the 41 cities has been completed and the demand is 2,24,960. HFAPoA of 18 cities completed. As per the demand survey, 5,594 beneficiaries under CLSS, 89,505 beneficiaries under ISSR, 87,161 beneficiaries under BLC and 37,306 beneficiaries under AHP verticals have demanded houses.
- ii. Annual Implementation Plan preparation is under process. It will be submitted to GOI before 15<sup>th</sup> Nov.
- iii. Out of 20,239 EWS houses under BLC projects for which Central Assistance was considered in the 4<sup>th</sup> and 6<sup>th</sup> CSMC meetings, 12,500 beneficiaries found ineligible have been removed. Out of the balance 7,739 beneficiaries, 6,661 houses are under construction and geo-tagging has been completed for 2767 houses.
- iv. Agreement with the beneficiaries is under process for 19933 houses, for which the central assistance was approved in the 12<sup>th</sup> CSMC meeting. Physical Verification has been completed of all the records submitted by the beneficiaries
- v. Validation with SECC data is not complete as qualitative SECC data is not available.
- vi. For 12814 new EWS beneficiaries proposed now, the documents have been verified and authenticated to avoid ineligibility.
- vii. The indicative building plan, approved by the Technical wing of UD&H Department may be revised as per the availability of land with the beneficiaries. Revision would be done after the approval of competent technical authority of the ULB ensuring NBC norms.
- viii. Recruitment for SLTC and CLTC is under process.

- ix. Utilization Certificate for Rs. 130.46 Cr is pending. The State representative informed that UC for a sum of Rs. 50 Cr would be submitted in the next 10 days, and the State shall look into for refunding the Rs. 30 Cr excess ACA available with the State in respect of JNNURM projects..
- x. Out of the 10,000 beneficiaries identified for CLSS component, only 1,488 applications were entertained by the Banks, and only 28 loans have been sanctioned. This is primarily because land is not transferrable in Jharkhand.

#### C. CSMC observations:

- i. State to ensure that adequate infrastructure is ensured including individual water and electric connection.
- ii. State to ensure that demarcation of land rights/ mutation is to be carried out before implementation.
- iii. There should be no change in the identified beneficiaries.
- iv. The State has not submitted any Utilization Certificate for JNNURM projects in the current financial year. The submission of U.C. and refunding of excess ACA should be expedited.
- v. The State Government should ensure that the funding is not duplicated for any beneficiary.
- vi. The State Government will provide project-wise and city-wise details of the 12,500 ineligible beneficiaries of the earlier considered BLC projects so that the Ministry can record the reduced size of the relevant projects and adjust the fund release in the corresponding cities at the time of future releases.

#### **D. CSMC Decisions:**

In view of the above, the CSMC:

- (i) accorded approval for Central Assistance amounting to Rs. 192.21 Crore for the 36 BLC Projects (New Construction) for construction of 12,814 houses in EWS category submitted by the State Government of Jharkhand under PMAY(Urban) as per details at **Annexure VI;** and
- (ii) recommended release of the first instalment of Central Assistance amounting to Rs. 76.884 Crore (40% of Central Assistance) for the 36 BLC (New Construction) projects.

10 Central Assistance for making provision of drinking water supply for slum households endemic with Acute Encephalitis Syndrome (AES)/ Japanese Encephalitis (JE) in 2 Municipalities i.e. Alipurduar and Mal submitted by **WEST BENGAL** 

#### A. Basic Information:

The proposal under consideration of CSMC was for approval of Central Assistance for making provision of drinking water supply for slum households in 2 municipalities i.e. Alipurduar and

Mal in Jalpaigudi district of West Bengal. The projects have been appraised by HUDCO. The salient details are as under:

HUDCO apprised the CSMC about the project components and observations pertaining to these projects.

#### **B. CSMC Observations:**

The CSMC observed that the project proposals have been developed with reference to surface (river) sources and population of whole town and not the slum house-holds endemic with Acute Encephalitis Syndrome (AES)/ Japanese Encephalitis (JE) has been considered in the project design in these Municipalities. CSMC also observed that there are major techno-economic issues involved in these projects.

#### **C. CSMC Decisions:**

The CSMC deferred the agenda and decided to form a sub –committee with officials/expert from technical and financial department as well as from M/o Health and Family Welfare for proper scrutiny of the projects before these are placed again before the CSMC for consideration of Central grant.

#### B. Additional information by the State:

- i. The State would be taking up 14 cities in phase I, 22 cities in phase II and 57 cities in phase III. In the phase I, till date 18 DPRs have been submitted for consideration under PMAY (7 BLC (new construction) projects for 8,382 beneficiaries, 7 BLC (enhancement) projects for 917 houses considered in the 9<sup>th</sup> CSMC and 4 DPRs with 5,968 beneficiaries in the present proposal). Demand Survey has been completed for 22 cities to be considered in phase II also, and till date, a demand of about 1,00,000 houses has been received.
- ii. The project proposals for the phase II cities would be submitted by December 2016.
- iii. The demand assessment for all the towns would be completed by March 2017.
- iv. The State government's scheme under housing department is for purchase of land by the land less beneficiaries. The State scheme is dovetailed with the PMAY(U), so that the beneficiary can purchase the land through State scheme and construct the house under BLC vertical of PMAY(U).
- v. The water supply to the households would be through hand pumps/ in-site wells or tap connection from Kerala Water Authority.
- vi. The Rural Kerala is going to be declared Open Defecation Free (ODF) in November 2016, and the Urban Kerala would be declared ODF in January 2017.

#### C. CSMC observations:

- i. HUDCO observed that out of the 4 type designs adopted by the State, 3 type designs have carpet area higher than 30 Sq Mt.
- ii. HUDCO also observed that the area of Bath and WC combined was lower than that required as per NBC norms. The State Government should ensure that the design of the houses

conforms to NBC norms.

- iii. The State Government should ensure that the Utilization Certificates pending for Rs. 172 Cr under JNNURM are submitted at the earliest.
- iv. 3,500 Dwelling Units are yet to start under JNNURM. The State Government should refund the ACA available for those Dwelling Units, since it would not be possible that the Dwelling Units are completed within the Mission period.
- v. The State Government is to furnish validated beneficiary list of the projects sanctioned in 9<sup>th</sup> CSMC meeting at the earliest.

#### D. CSMC Decision:

In view of the above, the CSMC:

- (i) accorded approval for Central Assistance amounting to Rs. 89.52 Crores for the 4 BLC Projects (New Construction) for construction of 5,968 houses in EWS category as proposed by the State Government of Kerala under PMAY(Urban) as per details at **Annexure-VII**; and
- (ii) recommended release of the first instalment of Central Assistance amounting to Rs. 35.808 Crores (40% of Central Assistance) for the aforesaid 4 BLC projects, subject to compliance to the CSMC's observations at para 11 C(ii & v).

12 Discussion on CLSS

#### 1. Manipur

7946 applications received. State Bank of India is major bank in the State. State Govt. to provide soft copy of the identified beneficiaries to the Ministry.

#### 2. Punjab

It was informed that the banks are not facilitating loan to the beneficiaries. Two banks namely Punjab National Bank and Punjab & Sind Bank are having branches all over the State. The Committee directed that this being a flagship programme of Government of India, State Govt may send a brief of problem areas and issues raised by these Banks so as to take up the issues with the Deptt of Financial Services.

#### 3. Jharkhand

28 potential beneficiaries have been identified. Banks are, however, raising concerns regarding possible default on repayment of loan on account of land ownership issues in the State. State Bank of India is the leading bank in the State.



#### Other important observations

13

The following important observations were made regarding project proposals under PMAY(U). States should take note of the observations of CSMC and take further action accordingly:

- 1. States/UTs must complete Demand assessment as well as submit the Housing for All-Plan of Action (HFAPoA) without any further delay, and get the projects approved by the State for availing Central Assistance under PMAY(U) at the earliest. This is important so that the States have enough time to complete the approved projects within the mission period.
- 2. CSMC requested the State Governments to expedite implementation of mandatory reform conditions by December 2016 so as to meet the Mission goals
- 3. States are requested to enter the beneficiary details from the demand survey, as well as project data in PMAY-MIS at the earliest. All beneficiaries must have a valid ID numbers, preferably Aadhar numbers. States are requested to get the beneficiaries' Aadhar enrolment numbers where the beneficiaries do not have Aadhar number. In cases where the beneficiaries have not applied for Aadhar numbers, the State should assist such beneficiaries to get them enrolled for Aadhar numbers.
- 4. All SLNAs and implementing agencies must register themselves on Public Finance Management System (PFMS) portal so that the fund flow could be tracked.
- 5. Under PMFS/DBT process, the funds would have to be transferred at every stage only through electronic mode. This may relate to PMAY (U) as under:
  - a. In case of Centrally Sponsored Schemes:
    - i. For Beneficiary Led individual house Construction (BLC), under PMAY

       (U), the bank account details of the beneficiaries should necessarily be mapped so that the funds can flow to the beneficiaries' bank account directly.
    - ii. In the case of Affordable Housing in Partnership (AHP) and In-Situ Slum Redevelopment (ISSR) projects under PMAY (U), the 2nd instalment to the State Government should be released only after receipt of beneficiary list with linkage of Aadhar numbers of the beneficiaries duly certified by the State Government/ UT concerned and uploaded in the PMAY- MIS portal.



- b. In the case of CLSS (Central Sector Scheme), the Central assistance is deposited upfront in the loan account of the beneficiary, after the bank receives the funds from CNAs.
- 6. State Level Appraisal Committee is expected to thoroughly appraise the DPRs before submitting it to State Level Sanctioning & Monitoring Committee for approval. Combining SLAC and SLSMC meeting is not permissible as the mandates of the two bodies are distinct.
- 7. Projects such as VAMBAY or JNNURM etc., which have already been funded under housing schemes of GoI should not be considered for further funding under PMAY-HFA(U).
- 8. ULBs are to ensure undertaking from the beneficiaries to the effect that they have not availed of funding under any other project/ schemes of GoI for the house being constructed/enhanced under PMAY(U).
- CSMC has been reviewing the progress of completion and occupancy of JNNURM and RAY projects with the concerned Authorities. The CSMC reiterated that the State Governments must expedite physical completion and occupancy of JNNURM and RAY houses.
- 10. Under the BLC projects, all individual houses shall have to be Geo-tagged on the BHUVAN- MHUPA application. Further, the **States are advised to release the funds** to beneficiary only after the beneficiary completes the construction up to foundation level through its own funds.

## Annexure IV: Hiring of additional experts in individual CLTCs of Amritsar, Ludhiana and Jalandhar submitted by PUNJAB

#### A. Basic Information:

- 1. State Government of Punjab has submitted the proposal for establishment of SLTC / CLTCs under PMAY-HFA (U) Mission for the Financial Year 2016-17. The State Government has intimated that this proposal has been considered in the SLSMC held on 15-09-2016, however, Minutes of the meeting is awaited from the State.
- 2. As the matter of establishment of SLTC in the State of Punjab, it is to inform that the proposal of State is as per approved Financial Norms. The Annual Budget for SLTC as per norms is Rs. 81.60 lakhs, out of which, Central share would be Rs. 61.20 lakhs (75% of total admissible amount). An amount of Rs. 30.60 Lakh (50% of Central share of Rs. 61.20 lakhs) has been release to the State of Punjab as a 1<sup>st</sup> installment.
- 3. With regard to the proposal for establishment of CLTCs (Individual & Cluster-wise), the State Government of Punjab has proposed to establish 09 CLTCs (3- individuals & 06 cluster-wise) comprising 39 professionals covering all 163 cities/towns included under the PMAY-HFA (U) Mission till date.
- 4. After examination of this proposal, the following has been noticed:
  - (i) With regard to the **2 individual** CLTCs [Amritsar & Ludhiana] having population more than 10 lakhs, State has proposed 05 specialists in each CLTC.
  - (ii) With regard to the **1 individual** CLTC [Jalandhar] having population between 5-10 lakhs, State Govt. Punjab has also proposed 05 professionals.

In this regard, it is apprised that as per the Mission Guidelines' Para-12.14 & approved financial norms, big cities like metropolitan cities can select more than 4 specialists with the approval of CSMC.

Since the population of 02 individual CLTCs [Amritsar & Ludhiana] is more than 10 lakhs, the proposal for hiring 05 specialists i.e. one more than the maximum of 04 in these 02 cities, is justified as per financial norms approved by the Ministry.

With regard to the rest of 01 individual CLTC at **Jalandhar** city having population between 5-10 lakhs, may not be considered as the population of the city is less than 10 lakh, hence it may not be considered as a big city like metropolitan city.

(iii) In respect of remaining 06 Cluster CLTCs, State has proposed 04 specialists in each which is as per approved financial norms approved by this Ministry.
