Minutes of the 62<sup>nd</sup> meeting of Central Sanctioning and Monitoring Committee (CSMC) under Pradhan Mantri Awas Yojana (Urban) - Housing for All Mission held on 24<sup>th</sup> June, 2022.

The 62<sup>nd</sup> meeting of Central Sanctioning and Monitoring Committee (CSMC) under Pradhan Mantri Awas Yojana - Urban (PMAY-U) was held on 24<sup>th</sup> June 2022 at 4.00 p.m.in the Conference Room, Nirman Bhawan, New Delhi, under the chairmanship of Secretary, Ministry of Housing and Urban Affairs (MoHUA) and attended by participants/representatives from the State/UT Governments, officers of the Ministry and other Departments etc. The list of participants is at **Annexure-I**.

The meeting began with welcome address by the Joint Secretary & Mission 2. Director (HFA). States/UTs (as in Annexure-I) of Andaman & Nicobar Islands, Andhra Pradesh, Arunachal Pradesh, Bihar, Chhattisgarh, Gujarat, Haryana, Himachal Pradesh, Jammu & Kashmir, Karnataka, Kerala, Ladakh Madhya Pradesh, Manipur, Meghalaya, Mizoram, Nagaland, Punjab, Puducherry, Rajasthan, Tripura, Uttar Pradesh and West Bengal attended the meeting. It was informed that MoHUA is celebrating 7 years of Pradhan Mantri Awas Yojana-Urban (PMAY-U) today, which was launched by Hon'ble Prime Minister Shri Narendra Modi on 25th June 2015. The seventh anniversary celebrations highlighted the important initiatives implemented under PMAY-U Mission over the years, responding to the need of changing time. The Ministry is proud to implement one of the largest urban housing programmes in the world in partnership of States/UTs. A movie depicting the glorious 7 years journey of PMAY-U was showcased highlighting how the Mission is fulfilling the dream of a pucca house for people of urban India.

The JS & MD (HFA) mentioned that the States/UTs may submit fresh proposals for sanction in forthcoming CSMC meetings, but it should be within the limit of proposed number of curtailment of houses. He further suggested that States/UTs may submit proposals in advance without waiting for announcement of CSMC meeting so that desk and site scrutiny of the project proposals are completed well in advance.

On the request of Mission Director (HFA) an **e-Book encapsulating achievements of the Mission** was released by Secretary, MoHUA. The book takes the readers through the initiatives and reforms that have been undertaken by the Mission to transform the urban landscape of India and more importantly, the impact it has had on the lakhs of beneficiaries of PMAY-U, who are proud owners of a pucca house with all basic amenities. The e-Book can be downloaded from PMAY-U website (<a href="https://pmay-urban.gov.in/">https://pmay-urban.gov.in/</a>).

Further, winners of **Khushiyon Ka Aashiyana** - a Short Film Contest were also declared. The contest was launched by MoHUA as part of Azadi ka Amrit Mahotsav celebrations. It was open to PMAY-U beneficiaries, students, youths, civil society organisations, institutions and individual/groups above 18 years of age during the period 1stJuly 2021 to 30th September 2021. The broad theme was 'Transforming Human Lives in Urban Landscape' through PMAY-U mission. It was informed that the contest received an overwhelming response from across India, especially from PMAY-U beneficiaries, who enthusiastically participated in the competition by sharing their life transforming experiences through films made by themselves. A total of 34 participants have been selected under three categories for recognition. The winners of the contest will get a cash prize and a certificate of recognition. The 1st Prize carries a cash reward of ₹ 25,000, 2nd prize ₹20,000 and the 3rd prize ₹12,500. The winners' names have been uploaded on PMAY-U website.

PMAY-U **field inspection module in dashboard** was also launched on the occasion by Secretary (HUA). The purpose is to assist visitors to inspect PMAY-U project sites/houses construction by beneficiaries with the help of just a mobile phone. The module can be used by the Ministry, Central Nodal Agencies, PMU members, State officials and respective SLTCs/CLTCs staff.

- 4. Joint Secretary & Mission Director (HFA), MoHUA made a presentation on **National Review** of execution of PMAY-U covering innovations by State/UT Governments. Few of them were listed as under:
- \* Releasing advance instalments to the beneficiaries of BLC component to start construction, resulting in faster progress by the States such as Uttar Pradesh, Assam, Bihar, Punjab and Rajasthan.
- ❖ Convergence with other Central & State Schemes leading to smooth implementation by Andhra Pradesh, Bihar, Karnataka, Kerala, Odisha, Himachal Pradesh and UT of J&K.
- ❖ Land titles/Patta to landless/slum dwellers by the States including Andhra Pradesh, Odisha, Madhya Pradesh, Chhattisgarh and Punjab.
- Addressal of slum housing through BLC and AHP components by Madhya Pradesh, Uttar Pradesh, Odisha, Kerala, Andhra Pradesh Tamil Nadu and Telangana.
- \* Ensuring Slum Upgradation through JAGA Mission by State Government of Odisha.
- Projects for special category groups (Leprosy, Transgender, Nomadic, Tribal etc.) by the States including Kerala, Jharkhand, Tamil Nadu, Andhra Pradesh, Telangana and Karnataka.

- \* Tripartite agreement (Bank, ULB & Beneficiary) for ensuring credit facility to beneficiaries undertaken by- Madhya Pradesh, Andhra Pradesh, Tamil Nadu and Karnataka.
- Concerted efforts of the States, leading to Best Performance under CLSS component of the Mission which includes Gujarat and Maharashtra.
- ❖ Cognizable efforts by NE & Hilly States despite difficult terrain and climatic conditions.
- ♦ Promotion of faster completion (within 3 months) through incentive of ₹ 20,000 by State of Odisha.
- ❖ Highest State share by Kerala, Tamil Nadu, Telangana, West Bengal and Gujarat.
- ❖ The campaign such as "Grih Pravesh" & "Neev Khudai Pakhwara" for accelerating grounding & completion MP and Jharkhand Governments.
- \* Special policy initiatives for PPP projects by Uttar Pradesh and Gujarat.
- ❖ Allotment of unutilized/vacant Govt. land @ ₹1 for AHP projects by Madhya Pradesh.
- ♦ Benefit to construction labours of upto ₹2 lakh in AHP projects from labour cess collection- Madhya Pradesh and Maharashtra.

The following **common issues** in respect of execution of PMAY-U were highlighted in the meeting:

## Grounding of non- starter houses:

- > State to ensure grounding of houses as per timelines:
  - Houses sanctioned before 31.03.2021- latest by 31.05.2022
  - Houses sanctioned till 30.06.2021- latest by 30.06.2022
  - Houses sanctioned after 30.06.2021- latest by 15.08.2022
- > State to submit Curtailment Plan and Grounding Plan upto July 2022 and expedite compliances for fund release.
- ➤ Submission of UCs against earlier releases such as Andhra Pradesh, Bihar, Haryana, Jharkhand, Kerala, Maharashtra, Manipur, Nagaland, Tripura, West Bengal and UT of J&K.
- > All States/UTs to submit Action Taken Reports (ATRs) on TPQMA reports duly approved by SLSMC.
- ➤ State to ensure early release of Central Assistance along with State matching share to ULBs/IAs/ Beneficiaries specially Chhattisgarh, Jammu & Kashmir, Maharashtra, Mizoram, Odisha, Puducherry, Punjab, Rajasthan, Uttar Pradesh, Uttarakhand.



## **Expedite Compliances for Fund Release:**

- > State to submit Social Audit Reports for claiming 3rd instalment of Central Assistance including Andhra Pradesh, Goa, Haryana, Himachal Pradesh, Maharashtra, Odisha, Rajasthan, Telangana, Sikkim, A&N Island, D&N Haveli and Daman & Diu, Jammu & Kashmir and Ladakh.
- ➤ State to deposit Interest Earned till 31st March 2021 & 2022 against released Central Assistance to CFI at the earliest specially Arunachal Pradesh, Bihar, Chhattisgarh, Haryana, Himanchal Pradesh, Jammu and Kashmir, Jharkhand Karnataka, Sikkim, Telangana, Puducherry, Gujarat, Maharashtra and Odisha.
- > No funds will be released by this Ministry towards 1st installment in sanctioned projects after 30.09.2022 (All States/UTs).

#### **MIS Issues:**

- > State to resolve all pending MIS issues urgently and submit necessary compliance for claiming 1st installment of Central Assistance by 15.08.2022. specially Bihar, Punjab, Uttar Pradesh, Tamil Nadu, Maharashtra, Assam, Odisha, Andhra Pradesh, Madhya Pradesh, West Bengal, Kerala and Karnataka.
- ➤ Updation of data in MIS etc. for claiming 2nd and 3rd instalments of Central Assistance by States of Bihar, Punjab, Uttar Pradesh, Tamil Nadu, Maharashtra, Assam, Odisha, Andhra Pradesh, Madhya Pradesh, West Bengal, Kerala and Karnataka.
- > Updation of Beneficiary fund released information in MIS by all States/UTs.
- > All States/UTs to regularly review the progress of geo-tagging of various stages of construction of houses and ensure that only good quality images are uploaded as these are in public domain.
- > States to ensure uploading of photograph of completed houses with PMAY-U Logo.

The minutes of the 61st meeting of CSMC under PMAY-U held on 5.5.2022 were confirmed.

Proposal for curtailment of 226 houses in 1 AHP project submitted by UT of Andaman & Nicobar Islands (Agenda 2)

## A. Basic Information:

The Committee was informed that UT Government of Andaman & Nicobar Islands has proposed for curtailment of 226 houses in 1 AHP project approved in 51st CSMC meeting. The reason for curtailment was mainly due to non-responsiveness of beneficiaries. The SLSMC in its meeting held on 31.5.2022 has approved the curtailment/surrender as under:

## B. CSMC Observations:

The UT Government should take due diligence in identifying the eligible beneficiaries while formulating the proposal and seeking approval of CSMC. It should be ensured that no eligible beneficiaries are deprived of the benefit due to the proposed curtailment. The UT Government may ensure proper documentation and record of the earlier identified beneficiaries to avoid any future dispute and resentment of the beneficiaries in case of curtailment/cancellation of the houses/projects.

#### C. CSMC Decision:

After detailed deliberations, the CSMC **approved** curtailment of 226 houses in 1 AHP project sanctioned in the CSMC meeting as proposed by the UT Government of **Andaman & Nicobar Islands** and directed as under:

a. UT must ensure that the DPRs where the curtailment has been proposed are revised accordingly and uploaded in the website of SLNA/Department immediately.

- b. Central Assistance released, if any, for these beneficiaries in different projects may be adjusted in subsequent releases to the UT.
- c. UT Govt. must ensure uploading of revised signed annexure (7B) and remove the curtailed beneficiaries from PMAY-U-MIS.
- d. State should ensure that no eligible and willing beneficiary is removed/curtailed.

The details of curtailed houses (CSMC-wise and project-wise) are at **Annexure** -

Addressing the participants on this occasion of 7th Anniversary of PMAY-U, the Secretary, MoHUA expressing his satisfaction mentioned that a lot has been achieved under the Mission but still a lot has to be achieved ahead. The States/UTs should focus on completion of sanctioned houses. While ensuring uninterrupted fund flow, we should inspire and encourage implementing agencies to complete the houses in faster manner. Local NGOs, Elected Representatives etc. may be engaged to connect with the beneficiaries by conducting ward level meetings and address the local issues, if any. The houses which cannot be completed due to any reason, should be curtailed without further delay. He further said that I am confidant that together we will be able to achieve the intended goal of the Mission within given timeframe.

## 2 GENERAL OBSERVATIONS

i. PMAY-U has completed its intended tenure on 31.3.2022. Further extension upto 31.3.2024 is under active consideration of the Government for completion of already approved projects. Now onwards, no additional houses will be sanctioned, and focus will remain on completion of houses.

Under Credit Linked Subsidy Scheme (CLSS), the subsidy will be released for all the applications approved till 31.3.2022 by the respective Central

Nodal Agencies (CNAs).

ii.

iii. The focus of the Mission is now on completion of all sanctioned projects with its deliverables, States/UTs need to draw an action plan for grounding and completion of all the sanctioned houses/projects within stipulated timeframe and further advised to launch a special drive/campaign for this purpose.

iv. The Central Assistance released under PMAY-U Mission should be utilized within the time frame stipulated in the respective sanction orders and registration of all ULBs on PFMS may be ensured by all State/UT Governments. This is a very important matter hence appropriate arrangements and safeguards must be built in. The EBR fund is an interest-bearing fund, and it is important that the funds so released to the States/UTs do not remain parked with SLNA/State/UT Governments but is utilized on fast pace for the purpose it has been released. Any interest earned on the parked fund will be refunded to CFI.

- v. States/UTs are advised to set a judicious limit in the PFMS in a manner that ULBs with faster progress are able to utilize funds commensurate with their performance, to enable faster completion of houses and ensure that their progress is not hampered due to lack of funds.
- vi. Under PFMS/DBT process, the funds would have to be transferred at every stage only through electronic mode for Beneficiary Led individual house Construction (BLC) under PMAY-U. The bank account details of the beneficiaries should necessarily be mapped so that the funds can flow to the beneficiaries' bank account directly. There should also be 100% Aadhaar linkages of beneficiaries in all AHP, BLC, ISSR and CLSS cases.
- vii. With regard to the vacant houses, if any, under JnNURM/RAY, the State Governments/UTs should look for realistic and pragmatic options for converting them into ARHCs.
- viii. States/UTs should use innovative, cost effective and high-quality construction technologies for constructing the housing units under PMAY-U and document the same. The tender documents should preferably be technology neutral and a clause of quality assurance for the potential bidders should be included.
- ix. State/UT Governments are advised to ensure that:
  - a. Adequate infrastructure is provided including individual water, sanitation and electricity connections.
  - b. There should be no duplication/change in the identified beneficiaries.
  - c. Demarcation of land and mutation is carried out before implementation of the projects.
  - d. The design and construction of houses are disaster resilient, and the specifications conform to IS/ NBC norms.
- x. It has come to notice that some individual/organizations are collecting registration money etc. from potential beneficiaries seeking dwelling units in PMAY-U fraudulently. The Ministry of Housing and Urban Affairs has not authorized any individual/organization/agency to collect application/ registration fee for applying for houses in PMAY-U. Thus, individual/agency /organization cannot collect any money/application fee from the beneficiary for enrolment under PMAY-U. All State/UT Governments may also issue disclaimer to this effect in their relevant websites/advertisements etc. to stop this kind of fraudulent activity.
- xi. State/UT Governments may prepare short films, printed literature/documents on projects undertaken under PMAY-U to showcase how lives of beneficiaries have transformed. It should be widely circulated both in print and electronic media and in various social media platforms for generating awareness. The State/UT Governments should also share with the Ministry high resolution photographs and video testimonials of beneficiaries whose houses have been completed.

- xii. A robust MIS System being critical for PMAY-U Mission, States/UTs need to constantly monitor the linking of beneficiaries to sanctioned projects in PMAY-U-MIS (<a href="https://pmaymis.gov.in">https://pmaymis.gov.in</a>). All States/UTs should ensure that the Aadhaar details of beneficiaries with regards to their number and name is accurate while updating in MIS.
- xiii. All States/ UTs should use PMAY MIS and related dashboard (<a href="https://dashboard.pmay-urban.gov.in">https://dashboard.pmay-urban.gov.in</a>) to review the district wise and ULB wise progress. Similarly Mobile Inspection module (<a href="https://dashboard.pmay-urban.gov.in/visitor">https://dashboard.pmay-urban.gov.in/visitor</a>) should be used by all officers visiting any PMAY Urban site so that inspection reports are integrated in dashboard.
- xiv. It has come to notice that data on progress of construction of houses reported in PMAY-U-MIS and those discussed in the CSMC meetings varies many a time. States/UTs must upload **online Monthly Progress**Reports (MPRs) of all sanctioned projects in PMAY-U-MIS <u>latest by 10<sup>th</sup> of every month</u> so that the data are reconciled before every CSMC meeting.
- xv. A PMAY-U Mobile App has already been provided by the Ministry to enable beneficiaries to upload their photos with their house and a video clip where beneficiaries share experience of owning a house under PMAY-U as testimonials. The App can be downloaded from Google Play Store. The State/UTs may inform their beneficiaries to upload the same using this Mobile App.

The meeting ended with a vote of thanks to the Chair.
