Affordable Housing and Slum Rehabilitation & Redevelopment Housing Policy – 2017



- Affordable Housing and Slum Rehabilitation & Redevelopment Housing Policy – 2017 notified by the State government.
- International Finance Corporation (IFC) selected as a transaction Advisor
- Projects of **4385 DUs** under AHP in Sasaram, Samastipur, Dalminagar, Gaya & Bahaglpur have been proposed on BSHB land on PPP mode.
- Project of **1166 DUs** under AHP in Bahadurpur, Patna and Damodarpur, Muzaffarpur have been proposed on BSHB land on PPP mode
- Project under In- Situ Slum Redevelopment (ISSR) is under process in Kamla Nehru Slum (Patna)

Fund Issue



- Funds released by Ministry project wise but UCs are compiling for all the projects approved in one CSMC at the time of release of 2nd installments
- If some units surrendered in one projects then ACA should be adjusted form that projects instead of all the projects approved in one CSMC.
- At the time of release of 2nd installment beneficiaries attachment should be consider project wise instead of all the projects approved in one CSMC
