Sub: Release of Central Assistance to State Government of Tamil Nadu under Pradhan Mantri Awas Yojana (PMAY) (Urban) Mission for the FY 2016-17.

Sir,

The undersigned is directed to convey the Sanction of the President of India to the payment of **Rs. 21,75,40,000/- (Rupees Twenty one crore seventy five lakh forty thousand only)** to the **State Government of Tamil Nadu** as central grant for Creation of Capital Assets under Pradhan Mantri Awas Yojana (PMAY) (Urban) Mission under Plan allocation for the FY 2016-2017.

2. The statement showing details of the projects against which the above Grant towards 1st installment of the Central Assistance stand sanctioned to State Government of Tamil Nadu is annexed.

3. This sanction is based on the approval and recommendation of CSMC of MoHUPA under Pradhan Mantri Awas Yojana (PMAY) (Urban) Mission in its 4th meeting held on 21st December, 2015. The amount of central grant is being released subject to the following conditions:

- (ii) Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
- (ii) The State Government and implementing agency shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- (iii) The State Govt./implementing agencies shall utilize the grant in accordance with the approved guidelines for the implementation of the Scheme of Pradhan Mantri Awas Yojana (PMAY) (Urban) Mission.
- (iv) The State Govt./ULB shall provide funds as approvals in the projects.
- (v) The State Government shall furnish Utilization certificates of the Grant released in the prescribed format (form 19-A) as per GFR – 2005 and as provided in the scheme guidelines.
- (vi) The funds may be utilized for the purpose for which these are sanctioned; otherwise these will have to be refunded along with interest as per provisions of GFR-2005.
- (vii) Transfers of funds to different entities and individual beneficiaries shall be made through PFMS/DBT mode, as applicable.

4. The sanctioned grant may be released to the State Government immediately. The fund may thereafter be released to the implementing agencies by the State Government without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.


