The undersigned is directed to convey the Sanction of the President of India to the release of Rs. 51,82,794/- (Rupees Fifty One Lakh Eighty Two Thousand Seven Hundred and Ninety Four only) to the State Government of Madhya Pradesh as central grant for Creation of Capital Assets under BLC component of Pradhan Mantri Awas Yojana (PMAY)- Housing for All (Urban) Mission under Plan allocation for the FY 2016-2017.

- 2. The statement showing details of the projects against which the above Grant towards 1<sup>st</sup> installment of the Central Assistance is annexed.
- 3. Based on decision of CSMC under Pradhan Mantri Awas Yojana (PMAY) Housing for All (HFA) (Urban) Mission in its 7<sup>th</sup> meeting held on 17<sup>th</sup> March, 2016 and on the recommendations made by MoHUPA, the amount of central grant is being released subject to the following conditions:
  - i. Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
  - ii. The States Government and implementing agency shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
- iii. Utilize the grant in accordance with the approved guidelines for the implementation of the Scheme of Pradhan Mantri Awas Yojana (PMAY) Housing for All (HFA) (Urban) Mission.
- iv. Furnish the Utilization certificates of the Grant released in the prescribed format as per GFR 2005 as provided in the scheme guidelines.
- v. The funds may be utilized for the purpose for which these are given. Otherwise these will have to be refunded along with interest as per provisions for GFR-2005.
- vi. Where there is an element of cash transfers to individual beneficiaries, the same may be made through DBT mode.
- vii. State Government will be required to certify that the specifications of the houses conform to NBC Standards and that requisite infrastructure will be provided by the State Government/ULB.
- viii. The State must mandatorily ensure data entry in PMAY-MIS and geo-tagging of photographs to monitor progress of the house construction before release of each installment to beneficiaries.
  - ix. The State to ensure the occupancy of houses under JNNURM and construction of houses sanctioned under RAY.

- 4. Payment may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
