Sir,

I am directed to convey the sanction of the Competent Authority to release an amount of Rs. **2,32,26,475/- (Rupees Two Crore Thirty Two Lakh Twenty Six Thousand Four Hundred and Seventy Five only)** to State Govt. of Himachal Pradesh as reimbursement of Central Assistance for SLTC and CLTCs for FY 2018-19 & FY 2019-20 and 1<sup>st</sup> installment of Central Assistance for SLTC with 7 Specialists and 14 CLTCs with 52 Specialists for FY 2020-21 under PMAY-U Mission. 2. Earlier, the fund of Rs. 156.29 lakh was released to State Govt. of Himachal Pradesh, out of which Rs. 17.65 lakh towards reimbursement of Central Assistance for SLTC for FY 2017-18 and Rs. 138.64 lakh as 1<sup>st</sup> instalment of Central Assistance for SLTC and 13 CLTCs for FY 2018-19, after adjustment of excess funds released earlier for CLTCs for FY 2017-18 under PMAY-U Mission vide sanction letter of even number dated 28.03.2020. The State Govt. has submitted the Utilization Certificate of Rs. 1,73,65,555/- against the funds released, which is enclosed herewith.

3. The above grant is subject to the following conditions:

- (i) The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- (ii) The State will utilize the sanctioned grant for the purpose for which it is released. The State Government/Nodal Agency shall furnish physical and financial progress reports every quarter.
- (iii) The State will furnish the Expenditure Statement/Utilization Certificate as per GFR 2017 along with the details of Specialists engaged subject to financial norms approved by 1<sup>st</sup> CSMC as well as adherence to scheme guidelines.
- (iv) The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- (v) The amount of Central Assistance approved will form a part of capacity building plan of the State under PMAY-HFA (Urban) mission.
- (vi) Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer, the same may be made through DBT/EAT module of PFMS as applicable.

4. In so far as Goods and Service Tax (GST) on salary for SLTC and CLTCs for FY 2018-19 and 2019-20 is concerned, it would be reimbursed on actual basis and on applicable sharing pattern after submission of relevant documents/vouchers as per Capacity Building guidelines.

5. The expenditure involved is debit to the following Head of Account under Demand No. 57 of Ministry of Housing and Urban Affairs for the year 2020-21:


