Sub: Release of ₹55.28 lakh as 2nd and final installment of Central Assistance (25%) to State Govt. of Odisha for preparation of HFAPoAs under PMAY-U Mission – reg.

Sir,

I am directed to convey the sanction of the Competent Authority to the release of **₹55,28,000/- (Rupees Fifty Five Lakh and Twenty Eight Thousand only)** as 2nd and final instalment of Central Assistance (25%) to State Govt. of **Odisha** for preparation of Housing for All Plan of Actions(HFAPoAs) for 85 towns under Pradhan Mantri Awas Yojana-Urban(PMAY-U) Mission. The details of towns/cities for which 2nd and final installment for HFAPoAs are being released are enclosed at **Annexure**.

2. Earlier, fund of ₹184.12 lakh and ₹335.42 lakh was released to State Govt. of Odisha for preparation of Slum Free City Plan of Action (SFCPoA) under Rajiv Awas Yojana (RAY) vide sanction letter No. 59(8)/PF-I/2009-829 dated 31.03.2010 and No. N-11027/53/2010-RAY-II(pt.) (FTS-867) dated 30.12.2013 respectively. Additionally, funds of ₹208.69 lakh for 42 cities, ₹240.19 lakh for 61 cities and ₹35.44 lakh for 9 cities were later released to State Govt. of Odisha as 1st installment (75%) of Central Assistance for preparation of HFAPoAs under PMAY-U Mission vide sanction letters No. N-11011/13/2015/HFA-II/FTS:13673 dated 24.11.2015, No. N-11015/02/2016/HFA-III/FTS:15671 dated 14.07.2016 and No. N-11015/07/2016/HFA-III/FTS:16698 dated 28.10.2016 respectively. State Govt. of Odisha has submitted Utilization Certificate (UC) for the entire amount of Central Assistance released for SFCPoA under RAY and HFAPoA under PMAY-U as detailed above, which is enclosed herewith.

3. State Govt. of Odisha has submitted 85 HFAPoAs which were placed before CSMC in its 51st meeting and CSMC has taken note of the HFAPoAs submitted by the State Govt.

4. The above grant is subject to the following conditions:

- i. The above release is only for those cities which are approved by this Ministry under HFA Mission, as detailed at **Annexure**.
- ii. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- iii. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- iv. The amount Central Assistance approved will form a part of capacity building plan of the state under PMAY-U Mission.

- v. Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer to individuals, the same may be made through DBT/EAT module of PFMS mode, as applicable.

5. The Expenditure is debit to the following Head of Account under Demand No. 57 of Ministry of Housing and Urban Affairs (MoHUA) for the financial year 2020-21:
