Sir.

The undersigned is directed to convey the Sanction of the President of India to the release of Rs.19,80,000/- (Rupees Nineteen Lakh and Eighty Thousand only) to State Govt. of Tamil Nadu as 1st instalment of Central Grant (Scheduled Tribe Component) for Creation of Capital Assets under Pradhan Mantri Awas Yojana (PMAY) (Urban) for the FY 2021-22.

- The statement showing details of the 08 AHP projects (out of 24 AHP Projects) considered in 50th CSMC meeting held on 27th December, 2019 against which the above Grant is released towards 1st instalment of the Central Assistance is annexed.
- Based on the decision and recommendations of CSMC under Pradhan Mantri Awas Yojana (PMAY) (Urban) in its 50th meeting and compliances achieved by State Govt. in respect of aforesaid projects, the amount of central grant is being released subject to the following conditions:
 - Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
 - The State Government and implementing agencies shall put in place a monitoring system ii. to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
 - The State Govt./implementing agencies shall utilize the grant in accordance with the iii. approved guidelines for the implementation of the Scheme of PMAY(U).
 - The State Govt./ULB shall provide funds as per approvals in the projects. iv.
 - The State Government shall furnish Utilization Certificates of the Grant released in the prescribed format (form 19-A) as per GFR - 2017 and as provided in the scheme guidelines.

- vi. The funds shall be utilized for the purpose and within selected categorized beneficiary for which these are sanctioned; otherwise these will have to be refunded along with interest as per provisions of GFR-2017.
- vii. State should ensure that data entry in PMAY (U) MIS portal is completed at the earliest. The Central Assistance is being released on the basis of work order and RERA registration entered in PMAY (U)-MIS. Remaining part of 1st instalment/Subsequent instalment will be released based on valid beneficiaries entered in PMAY (U)-MIS.
- viii. The State Government shall ensure the geo-tagging of all houses approved under AHP component of PMAY(U).
- ix. State Government shall ensure that the specifications of the houses conform to NBC/IS Standards and that requisite infrastructure will be provided by the State Government/ULB.
- x. State Government shall submit the Action Taken Report (ATR) on the observations/recommendations of Third Party Quality Monitoring Agency (TPQMA) for quality monitoring purpose before release of subsequent instalment.
- xi. The agencies responsible for implementation of PMAY (U) should get themselves registered on PFMS portal.
- xii. Transfers of funds to different entities and individual beneficiaries shall be made through PFMS/DBT, as applicable.
- xiii. State Government should ensure that there is no violation of Model Code of Conduct while releasing funds to implementing Agencies/ULBs/Beneficiaries.
- 4. Release of the Grant may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
- 5. The amount is debitable from the account of the Central Government in the books under the following Head of Account under Demand No. 59 of M/o Housing and Urban Affairs for the year 2021-22:
