- 2. Earlier, fund of Rs. 232.26475 lakh was released to State Govt. of Himachal Pradesh, out of which Rs. 73.77475 lakh was towards reimbursement of Central Assistance for SLTC and CLTCs for FY 2018-19 and 2019-20, and Rs. 158.49 lakh as 1<sup>st</sup> instalment of Central Assistance for SLTC with 7 Specialists and 14 CLTCs with 52 Specialists for FY 2020-21 under PMAY-U Mission vide sanction letter of even number and dated 02.12.2020. The State Govt. has submitted the Utilization Certificate (UC) of Rs. 232.26475 lakh against the said release, which is attached herewith.
- 3. The above grant is subject to the following conditions:
  - The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
  - ii. The State will utilize the sanctioned grant for the purpose for which it is released. The Govt. of Uttarakhand/Nodal Agency shall furnish physical and financial progress reports every quarter.
- iii. The State will furnish the Expenditure Statement/Utilization Certificate as per GFR 2017 along with the details of Specialists engaged subject to financial norms approved by 1st CSMC as well as adherence to scheme guidelines.
- iv. Further installment of funds will be considered on receipt of expenditure statement/UC from the State Govt. along with details of specialists engaged subject to financial norms approved by 1<sup>st</sup> CSMC as well as adherence to scheme guidelines, furnishing clarifications/supporting documents and submission of pending UCs under RAY, if any.
- v. The State Govt./Nodal Agency shall strictly monitor the progress of the preparatory work. All bills/voucher etc. should be safely kept at SLNA level for future audit and other references.
- vi. The amount of Central Assistance approved will form a part of capacity building plan of the State under PMAY-U mission.
- vii. Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer to individuals, the same may be made through DBT/EAT module of PFMS mode, as applicable.
- 4. The expenditure involved is debitable to the following Head of Account under Demand No. 59 of Ministry of Housing and Urban Affairs for the year 2021-22.
