

Sir,

I am directed to convey the sanction of Competent Authority to release an amount of **₹2,75,000/- (Rupees Two Lakh and Seventy Five Thousand only)** to State Govt. of Tripura as 2nd and final instalment of Central Assistance for conducting Social Audit (SA) for FY 2019-20 under Pradhan Mantri Awas Yojana – Urban (PMAY-U) Mission. The details of release are as under:

2. Earlier, out of admissible Central Assistance of ₹5.50 lakh, fund of ₹2.75 lakh was released to State Govt. of Tripura as advance amount of 1st instalment of Central Assistance towards Social Audit for FY 2019-20 under Capacity Building activities of PMAY-U Mission vide sanction letter No. N-11015/21/2019-HFA-V-UD (FTS-9081103) dated 27.01.2020. The State Govt. has submitted the Utilisation Certificate (UC) of ₹2.75 lakh against the said release, which is enclosed herewith.

3. State Govt. of Tripura has conducted Social Audit for FY 2019-20 and submitted the report along with city-wise list of Social Audit Committee members and copy of sample tools used for Social Audit, in compliance to conditions mandated for release of 2nd instalment of Central Assistance for Social Audit.

4. The above grant is subject to the following conditions:

- The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- The State will utilize the sanctioned grant for the purpose for which it is released.
- The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.

- iv. The amount of Central Assistance approved will form a part of capacity building plan of the State under PMAY-U.
 - v. Where there is an element of cash transfer, if any, the same may be made through DBT/EAT module of PFMS as applicable.
5. The amount is debitible under the following Head of Account under Demand No. 59 of the Ministry of Housing and Urban Affairs for the financial year 2021-22:




