**Sub: Release of ₹88.83 lakh to State Govt. of Mizoram as 2<sup>nd</sup> installment of Central Assistance for SLTC and 8 CLTCs for FY 2021-22 under PMAY-U Mission - reg.**

Sir,

I am directed to convey the sanction of the Competent Authority to release an amount of **₹88,83,000/- (Rupees Eighty Eight Lakh and Eighty Three Thousand only)** to State Govt. of Mizoram as 2<sup>nd</sup> installment of Central Assistance for SLTC with 8 Specialists and 8 CLTCs with 30 Specialists for FY 2021-22 under Pradhan Mantri Awas Yojana – Urban (PMAY-U) Mission. Details are enclosed at **Annexure-I & II** and are also as under:

2. Earlier, fund of Rs. 176.619 lakh was released to State Govt. of Mizoram, out of which Rs. 86.709 lakh was towards reimbursement of Central Assistance for SLTC/CLTCs for FY 2020-21 and Rs. 89.91 lakh as 1<sup>st</sup> installment of Central Assistance for SLTC with 8 Specialists and 8 CLTCs with 30 Specialists for FY 2021-22 under PMAY-U Mission vide sanction letter of even number dated 17.11.2021. The State Govt. has submitted the Utilization Certificate (UC) of ₹89.91 lakh, which is enclosed herewith.

3. The above grant is subject to the following conditions:

- i. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- ii. The State will utilize the sanctioned grant for the purpose for which it is released. The State Government/Nodal Agency shall furnish physical and financial progress reports every quarter.





- iii. The State will furnish the Expenditure Statement/Utilization Certificate as per GFR 2017 along with the details of Specialists engaged subject to financial norms approved by 1<sup>st</sup> CSMC as well as adherence to scheme guidelines.
- iv. Further installment of funds will be considered on receipt of expenditure statement/UC from the State Government along with details of specialists engaged subject to financial norms approved by 1<sup>st</sup> CSMC as well as adherence to scheme guidelines, furnishing clarifications/supporting documents and submission of pending UCs under RAY, if any.
- v. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work. All bills/ voucher etc. should be safely kept at SLNA level for future audit and other references.
- vi. The amount of Central Assistance approved will form a part of capacity building plan of the State under PMAY-U mission.
- vii. Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer to individuals, the same may be made through DBT/EAT module of PFMS mode, as applicable.

4. The expenditure involved is debit to the following Head of Account under Demand No. 59 of Ministry of Housing and Urban Affairs for the year 2021-22:
