Sir,

I am directed to convey the sanction of the Competent Authority to the release of ₹19,29,358/- (Rupees Nineteen Lakh Twenty Night Thousand Three Hundred and Fifty Eight only) as 2nd and final instalment of Central Assistance (25%) to State Govt. of Odisha for preparation of Housing for All Plan of Actions (HFAPoAs) for 27 towns under Pradhan Mantri Awas Yojana - Urban (PMAY-U) Mission. The details of said release are at Annexure.

- Earlier, funds of ₹208.69 lakh for 42 cities, ₹240.19 lakh for 61 cities and ₹35.44 lakh 2. for 9 cities were released to State Govt. of Odisha as 1st instalment (75%) of Central Assistance for preparation of HFAPoAs under PMAY-U Mission vide sanction letters No. N-11011/13/2015/HFA-II/FTS:13673 dated 24.11.2015, No. N-11015/02/2016/HFA-III/FTS:15671 dated 14.07.2016 and No. N-11015/07/2016/HFA-III/FTS:16698 dated 28.10.2016 respectively. Subsequently, funds of ₹55.28 lakh were also released to State Govt. of Odisha as 2nd and final instalment of Central Assistance (25%) to State Govt. of Odisha for preparation of HFAPoAs for 85 cities under PMAY-U Mission vide sanction letter of even number and dated 18.12.2020. State Govt. of Odisha has submitted Utilization Certificate (UC) for the entire amount of Central Assistance released for HFAPoA under PMAY-U as detailed above, which is enclosed herewith.
- 3. State Govt. of Odisha has submitted 27 HFAPoAs which were placed before Central Sanctioning and Monitoring Committee (CSMC) in its 46th, 53rd and 58th meetings and CSMC has taken note of the HFAPoAs submitted by the State Govt.
- 4. The above grant is subject to the following conditions:
 - The State will utilize the sanctioned grant for the purpose for which it is released. The State will also furnish the Utilization Certificate as per GFR 2017.
 - ii. The above release is only for those cities which are approved by this Ministry under HFA Mission, as detailed at **Annexure**.
- iii. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- iv. The State Government/Nodal Agency shall strictly monitor the progress of the preparatory work.
- v. The amount Central Assistance approved will form a part of capacity building plan of the state under PMAY-U Mission.

- vi. Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer to individuals, the same may be made through DBT/EAT module of PFMS mode, as applicable.
- 5. The Expenditure is debitable to the following Head of Account under Demand No. 59 of Ministry of Housing and Urban Affairs (MoHUA) for the financial year 2021-22:
