The details of said release are at Annexure.

- 2. Earlier, funds of ₹311.06 lakh, ₹78.75 lakh and ₹200.8125 lakh were released to State Govt. of Andhra Pradesh as 1st instalment (75%) of Central Assistance for preparation of HFAPoAs for 111 cities under PMAY-U Mission vide Sanction letters No. N-11011/13/2015/HFA-II/FTS:13673 dated 24.11.2015, No. N-11015/01/2015/HFA-II/FTS:13673 dated 30.05.2016 and Sanction letter of even number dated 12.04.2019 respectively. State Govt. of Andhra Pradesh has submitted Utilization CertificateS (UCs) for the entire amount of Central Assistance released for HFAPoAs under PMAY-U, which is enclosed herewith.
- 3. State Govt. of Andhra Pradesh has submitted 110 HFAPoAs for 110 ULBs/towns, which were placed before CSMC in its 43rd, 51st, 52nd and 56th meetings and CSMC has taken note of the said HFAPoAs submitted by the State.
- 4. The above grant is subject to the following conditions:
 - The State will utilize the sanctioned grant for the purpose for which it is released. The State will also furnish the Utilization Certificate as per GFR 2017.
 - ii. The above release is only for those cities which are approved by this Ministry under HFA Mission, as detailed at **Annexure**.
 - iii. The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.
- iv. The amount Central Assistance approved will form a part of capacity building plan of the state under PMAY-U Mission.
- v. Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer to individuals, the same may be made through DBT/EAT module of PFMS mode, as applicable.
