- (v) The amount of Central assistance approved will form a part of capacity building plan of the State under PMAY-U Mission.
- (vi) Transfer of funds to different entities may be made through PFMS, as applicable; and where there is an element of cash transfers to individual beneficiaries, the same may be made through DBT/EAT module of PFMS mode, as applicable.
