**Sub: Release of Rs. 27,19,116/- to State Govt. of Himachal Pradesh as 2<sup>nd</sup> and final instalment of Central Assistance for the projects sanctioned up to April 2022 for conducting TPQM under Capacity Building Activities under PMAY-U Mission – reg.**

Sir,

I am directed to convey the Sanction of the Competent Authority for release of **Rs. 27,19,116/- (Rupees Twenty Seven Lakh Nineteen Thousand One Hundred and Sixteen only)** to State Govt. of Himachal Pradesh as 2<sup>nd</sup> and final instalment of Central Assistance for the projects sanctioned up to April 2022 for conducting Third Party Quality Monitoring (TPQM) under Capacity Building activities of Pradhan Mantri Awas Yojana - Urban (PMAY-U) Mission under SLS HP48 - 1989 - Pradhan Mantri Awas Yojana – Housing for All(URBAN). The details of release are at **Annexure** and also as under:

2. Earlier, fund of Rs. 27,19,116/- {Rs. 4,51,440/- as 1<sup>st</sup> instalment of Central Assistance for the projects sanctioned for FYs 2015-16, 2016-17 & 2017-18 vide sanction letter No. N-11015/16/2018-HFA-V-UD (FTS-9054825) dated 22.02.2019, Rs. 16,08,120/- as 1<sup>st</sup> instalment of Central Assistance for the projects sanctioned for FYs 2018-19 & 2019-20 vide sanction letter No. N-11011/49/2017/HFA-I/V(FTS-9033058) dated 20.03.2020 and Rs. 6,59,556/- as balance amount of 1<sup>st</sup> instalment of Central Assistance for the projects sanctioned up to April 2022 vide sanction letter of even number dated 27.01.2023} was released to State Govt. of Himachal Pradesh for conducting TPQM under Capacity Building activities under PMAY-U Mission. The State Govt. has submitted the entire Utilization Certificates (UCs) against the said release, which is **enclosed** herewith. The State Govt. of Himachal Pradesh has also released and utilized the corresponding State share (10%).

3. The above grant is subject to the following conditions:

- i. PMAY-U being a Centrally Sponsored Scheme (CSS), the State Govt. should strictly follow the revised procedure of fund flow as per O.M. No. 1(13) PFMS/FCD/2020 dated 23<sup>rd</sup> March 2021 issued by Department of Expenditure, Ministry of Finance, Government of India and subsequent instructions issued in this regard. These instructions have been made effective from 1st July 2021 which inter-alia provides that

- a. Based on the authorization, the State Govt. shall transfer the Central Assistance as well as commensurate State share to the Single Nodal Account (SNA) within 30 days of receipt of Central Assistance failing which penal interest at the rate of 7% per annum will be charged on the number of days of delay beyond 30 days in transfer of Central Assistance to the SNA account.
  - b. Central Assistance along with State share, if any are to be kept by the Nodal Agency in the Single Nodal Account (SNA) opened in a Scheduled Commercial Bank for the purpose and the same is mapped in PFMS. The nodal agency will allocate drawing limits to Implementing Agencies (IAs) having zero balance subsidiary accounts duly mapped in PFMS and linked to SNA account for drawal of funds on real time basis from the Single Nodal Account.
  - c. The nodal agency shall ensure that the interest earned from the funds released, should be mandatorily remitted to respective consolidated funds on pro-rata basis in terms of rule 230(8) of GFR 2017.
  - d. SNAs and IAs will mandatorily use the DBT/EAT module of PFMS or integrate their systems with the PFMS to ensure that information on PFMS is updated by each IA at least once every day.
  - e. SNA will keep all the funds received in the Single Nodal Account only and shall not divert the same to Fixed Deposits/Flexi-Account/Multi-Option Deposit Account/Corporate Liquid Term Deposit (CLTD) Account etc.
  - f. Further releases under the scheme will be made only after transfer of entire Central Assistance released till date along with corresponding State share, if any, in the SNA account and utilization of 75% of earlier releases along with corresponding State share.
- ii. The TPQM agencies will undertake field visits for ascertaining quality of construction at various stages of construction as per PMAY-U TPQM Reference Guide. 'Visits' include examining/reviewing project documents and implementation and conducting any required tests/assessments and report writing. Each State will report the progress of TPQM on a quarterly basis.
  - iii. Central Assistance for this purpose will be limited to 3 'visits' to each project. The State/ULBs are free to include more field visits by TPQMA, as necessary. For Central Assistance, the States will adopt an open and transparent procedure for procurement of these services.
  - iv. The detailed TPQM report of quality assurance will be scrutinized at the level of SLNA and the SLNA will implement all the remedial measures suggested by TPQMA. The SLNA will place the TPQM report along with the Action Taken Report (ATR) before the SLSMC, as per relevant formats under Reference Guide for TPQM.
  - v. Subsequent and final instalment will be released on receipt of the Undertaking in the prescribed format under Reference Guide for TPQM along with Utilization Certificate (UC) as per GFR 2017 and ATR based on TPQM report by the States duly signed.
  - vi. The Ministry can ask for any specific TPQM report for further scrutiny, if required. The TPQM report should also be placed in the website of the SLNA.
  - vii. The States will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.

- viii. The States will utilize the sanctioned grant for the purpose for which it is released.
- ix. The State Governments/Nodal Agencies shall strictly monitor the progress of the preparatory work.
- x. The amount of Central Assistance approved will form a part of capacity building plan of the States under PMAY-U Mission.
- xi. Where there is an element of cash transfer, if any, the same may be made through PFMS/DBT mode as applicable.






