Subject: Release of ₹11,96,00,000/- to the State Government of Gujarat as 2nd installments of Central assistance for RAY projects for the financial year 2023-24 reg.

Sir.

I am directed to convey the sanction of the President of India to the release ₹11,96,00,000/-(Rupees eleven crore ninety six lakh only) to the State Government of Gujarat as 2nd installments of Central assistance for creation of Capital Assets for projects under Rajiv Awas Yojana (RAY) subsumed in Pradhan Mantri Awas Yojana – Urban (PMAY-U) for the FY 2023-24 under SLS GJ127 - GUJ-PMAY AHM – 1989. Details of the projects/release are at annexure.

- 2. Based on the decision and recommendations of CSMC and compliances achieved by State Government the amount of central grant is being released subject to the following conditions:
 - i. Necessary sanctions/ approvals/ compliances required under the statutory or other regulatory regime as applicable would be obtained by the authority (ies) concerned with the project (s).
 - ii. The State Government and implementing agencies shall put in place a monitoring system to ensure that the project (s) achieve scheduled milestone and envisaged outcomes including implementation of reforms and other conditionalities required under the scheme.
 - iii. These projects shall be completed in all respect within the period of PMAY-U (as subsumed RAY liabilities) for implementation of projects.
 - iv. The State Govt./implementing agencies shall utilize the grant in accordance with the approved guidelines for the implementation of the RAY Scheme.
 - v. The State Government shall furnish the Utilization Certificates of the Grant released in the prescribed format as per GFR-2017 and as provided in the scheme guidelines. The funds shall be utilized for the purpose for which these are sanctioned otherwise these will have to be refunded along with interest as per provisions in GFR-2017.
 - vi. The RAY scheme, subsumed under PMAY-U, being a Centrally Sponsored Scheme (CSS), the State Government should strictly follow the revised procedure of fund flow as per instructions issued by Department of Expenditure, Ministry of Finance, Government of India vide O.M. No. 1(13)PFMS/FCD/2020 dated 23rd March 2021. These instructions have been made effective from 1stJuly, 2021 which inter-alia provides that
 - a. The State Govt, will transfer the Central share as well as commensurate State share to the Single Nodal Account (SNA) within 30 days of receipt of Central share, failing which penal interest @ 7% per annum will be charged on the number of days of delay beyond 30 days in transfer of Central share to SNA account.

- b. Central Assistance along with state share are to be kept by the Nodal Agency in the Single Nodal Account (SNA) opened in a Scheduled Commercial Bank for the purpose and the same is mapped in PFMS. The nodal agency will allocate drawing limits to implementing agencies (IAs)having zero balance subsidiary accounts duly mapped in PFMS and linked to SNA account for drawal of funds on real time basis from the Single Nodal Account.
- c. The nodal agency shall ensure that the interest earned from the funds released, should be mandatorily remitted to respective consolidated funds on pro rata basis in terms of rule 230(8) of GFR 2017.
- d. SNAs and IAs will mandatorily use the DBT/EAT module of PFMS or integrate their systems with the PFMS to ensure that information on PFMS is updated by each IA at least once every day.
- e. SNA will keep all the funds received in the Single Nodal Account only and shall not divert the same to Fixed Deposits/Flexi-Account/Multi-Option Deposit Account/Corporate Liquid Term Deposit (CLTD) Account etc.
- f. Further releases under the Scheme will be made only after transfer of entire Central assistance released till date along with corresponding State share in the SNA account and utilization of 75% of earlier releases along with corresponding State share.
- vii. State Government shall ensure that the specifications of the houses conform to NBC/IS Standards and that requisite infrastructure will be provided by the State Government/ULB.
- viii. State Government should ensure that there is no violation of Model Code of Conduct while releasing funds to implementing Agencies/ULBs/Beneficiaries.
- 3. Release of the Grant may kindly be made to the State Government immediately. The funds may thereafter be released to the implementing agencies without any delay failing which the amounts would be recovered from the State Government with interest for the period of default.
- 4. The amount of is debitable from the account of the Central Government in the books under the following Head of Account under Demand No. 60 of M/o. Housing and Urban Affairs for the year 2023-24:

- 7. Requisite UCs for release of 1st installment of Central Assistance has been received from the State of Gujarat and is enclosed herewith.
- 8. This issues with the concurrence of the Finance Division vide their Note#116 dated 27-03-2024.
- 9. This sanction has been registered at S.No. 673 in the Sanction Register of HFA Directorate (HFA.III Section) of the Ministry of HUA for the year 2023-24.
