I am directed to convey the mother sanction of the competent authority for release of **Rs. 47,47,000/- (Rupees Forty Seven Lakh and Forty Seven Thousand only)** to State Govt. of Meghalaya on account of revalidation of lapsed amount of mother sanction of Rs. 57.24 lakh issued in FY 2024-25 through SNA SPARSH vide sanction letter of even number dated 13.03.2025, as 2nd installment of Central Assistance for SLTC and 3 CLTCs for FY 2024-25 under Capacity Building activities of Pradhan Mantri Awas Yojana - Urban (PMAY-U) Mission for FY 2025-26 under SLS ML449 - PRADHAN MANTRI AWAS YOJNA - HOUSING FOR ALL (PMAY)- CAPACITY BUILDING through SNA SPARSH. The State Government is required to contribute approved matching State share under the scheme. State to ensure timely release of matching State share.

As per rule 236(1) of GFR 2017, the relevant accounts of the Grantee institution(s)/Organisation(s) shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG(DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.
