Sir,

I am directed to convey the mother sanction of Competent Authority to release an amount of **Rs. 2,75,000/- (Rupees Two Lakh and Seventy Five Thousand only)** to State Govt. of Haryana as 2nd & final installment of Central Assistance for FY 2023-24 for conducting Social Audit under Capacity Building activities of Pradhan Mantri Awas Yojana - Urban (PMAY-U) Mission under SLS HR345 - HR Pradhan Mantri Awas Yojana - Urban Capacity Building (100 percent) 1989 through SNA SPARSH. Earlier, fund of Rs. 5.50 lakh was released to State Govt. of Haryana as 2nd & final installment of Central Assistance for FY 2022-23 and 1st instalment of Central Assistance for FY 2023-24 for conducting Social Audit under Capacity Building activities of PMAY-U Mission vide sanction letter No. N-11012/34/2019-HFA-V-UD (FTS-9062286) dated 20.09.2024. The State Govt. has submitted the entire Utilization Certificate (UC) against the said release, which is **enclosed** herewith.

3. State Govt. of Haryana has also submitted the documents mandated for release of 2nd & final installment of Central Assistance for FY 2023-24 for conducting Social Audit under Capacity Building activities of PMAY-U Mission.

4. The above grant is subject to the following conditions:

- The State will comply with the terms and conditions stipulated in the guidelines, CSMC directions and instructions issued by this Ministry.

- ii. The State will utilize the sanctioned grant for the purpose for which it is released and furnish the UC as per GFR 2017.
 - iii. The State Governments/Nodal Agency shall strictly monitor the progress of the preparatory work.
 - iv. The amount of Central Assistance approved will form a part of capacity building plan of the State under PMAY-U Mission.
 - v. Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer to individuals, the same may be made through DBT/EAT module of PFMS mode, as applicable.
 - vi. Any unspent balance lying in State Treasury/SNA Accounts prior to onboarding of the State Government on SNA SPARSH will be subject to guidelines issued by Department of Expenditure (DoE) from time to time.
5. The expenditure involved is debitale to the following Head of Account under Demand No. 60 of Ministry of Housing and Urban Affairs for the year 2025-26:

6. This admissible Central liability will be released to the Govt. of Haryana on demand through SNA SPARSH only or/and as per the latest guidelines of DoE. As the State has on boarded SNA SPARSH, all the committed liabilities shall be released in SNA SPARSH only. The State Govt. is required to contribute approved State matching share under the scheme. The State to ensure timely release of State matching share.

7. As per rule 236(1) of GFR, 2017, the relevant accounts of the Grantee Institution(s)/ Organisation(s) shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.

8. This issues with the concurrence of the Integrated Finance Division vide **Notes # 257-259 of even number dated 04.09.2025.**
