Sub: Release of advance of subsidy to National Housing Bank (NHB) under Interest Subsidy Scheme vertical of PMAY-U 2.0.

Sir.

I am directed to convey the sanction of the President of India for release of ₹35,00,00,000/- (Rupees thirty five crore only) as advance subsidy to National Housing Bank (NHB) being the Central Nodal Agency for implementation of Interest Subsidy Scheme vertical of PMAY-U 2.0 for making direct release to the Primary Lending Institutions (PLIs) which have signed MoUs with NHB under the scheme, based on the claims submitted by PLIs towards the loans disbursed as per the scheme for the FY 2024-25.

- 2. The release of funds to CNA is further subject to the following terms and conditions:-
- (i) The release made by MoHUA shall be kept in a separate designated account for utilization towards the implementation of the scheme and shall not form part of their general financial operations.
- (ii) The money will be utilised only for the purpose for which it has been sanctioned. Otherwise, these will have to be refunded along with interest as per provisions under GFR-2017
- (iii) CNA will exercise requisite checks and due diligence in settlement of claims.
- (iv) CNA will obtain required data and documents from the respective PLI and furnish a utilization certificate towards the release made as soon as possible.
- (v) The subsequent amounts of interest subsidy will be released to CNA after 75% utilization of earlier released amounts, on quarterly basis, and based on claims raised by CNA in the prescribed format (Annexure 11 and its enclosure as per scheme guidelines).
- (vi) Subsidy will be credited by the PLI to the borrower's account by deducting it from the principal loan amount of the borrower within 7 days from the date of fund release by CNA to PLI and updating on Unified Web-Portal.
- (vii) PLIs will be given a lump sum amount of ₹4,000/- per sanctioned application in lieu of processing fee for housing loan for the borrower under the scheme. In order to incentivize the designated staff of ULBs or NGOs a sum of ₹500 per sanctioned application would be paid out of ISS funds payable through State/UT Governments.
- (viii) 0.1 % of total fund disbursement to the PLIs will be paid to CNA for their administrative expenses for which CNA will furnish the details to MoHUA.
- (ix) CNA will submit progress reports including the details of expenditure to MoHUA regularly in the prescribed formats.
- (x) Where there is an element of cash transfer the same may be made through PFMS/DBT mode as applicable.

Sub: PMAY (U) 2.0 - ISS: Release of Funds for subsidy disbursement to PLIs

This is in reference to your telephonic discussion with Sh. Sourav Seal, General Manager, Government Schemes Department, regarding raising the demand for the Subsidy under PMAY(U) 2.0 - ISS for the applications approved by National Housing Bank (NHB).

In this regard, we submit that as per the data available on the Unified Web Portal (UWP), as on date, 1443 applications have been forwarded by Primary Lending Institution (PLIs) to the NHB on UWP, out of which 221 applications with total subsidy claim of ₹75,86,126/-have been approved by NHB as a CNA and forwarded to Ministry. Remaining 1222 cases have been queried to the respective PLI due to inconsistency of information in the applications received.

As per the process of claim & release of subsidy by NHB as a CNA, under PMAY(U) 2.0 - ISS, disbursement of subsidy to PLIs is subject to submission of Claim Applications Forms (CAFs) by the PLIs on the portal and acceptance of CAFs by the NHB. As you are aware that the same system of submitting and accepting CAFs in the UWP portal has been made available today only, the final submission of CAFs by the PLI and acceptance of the same by the CNA will require some time.

Considering the above, as of now it is difficult for the NHB as a CNA to forecast the requirement of subsidy amount for next one month.

However, as per the above discussion, as of now fund amounting to ₹50 crore may be released to the NHB as a CNA. The same will be disbursed to the respective PLIs based on the applications processed and accepted by NHB in due course.

यह राष्ट्रीय आवास बैंक द्वारा अनुमोदित आवेदनों के लिए प्रधानमंत्री आवास योजना (शहरी) 2.0 - आईएसएस के अंतर्गत सब्सिडी की मांग बढ़ाने के संबंध में सरकारी योजना विभाग के महाप्रबंधक श्री सौरव सील के साथ आपकी दूरभाष पर हुई चर्चा के संदर्भ में है।

इस संबंध में, हम प्रस्तुत करते हैं कि एकीकृत वेब पोर्टल पर उपलब्ध आंकड़ों के अनुसार, आज तक, प्राथमिक ऋणदाता संस्थानों द्वारा एकीकृत वेब पोर्टल पर राष्ट्रीय आवास बैंक को 1443 आवेदन भेजे गए हैं, जिनमें से ₹75,86,126/- के कुल सब्सिडी दावे वाले 221 आवेदनों को राष्ट्रीय आवास बैंक द्वारा केंद्रीय नोडल एजेंसी के रूप में स्वीकृत किया गया है और मंत्रालय को भेजा गया है। शेष 1222 प्राप्त आवेदनों को सूचना की असंगतता के कारण संबंधित प्राथमिक ऋणदाता संस्थान से पूछताछ के लिए भेजा गया है।

प्रधानमंत्री आवास योजना (शहरी) 2.0 - आईएसएस के अंतर्गत, केंद्रीय नोडल एजेंसी के रूप में राष्ट्रीय आवास बैंक द्वारा सब्सिडी के दावे और जारी करने की प्रक्रिया के अनुसार, प्राथमिक ऋणदाता संस्थानों को सब्सिडी का संवितरण, पोर्टल पर प्राथमिक ऋणदाता संस्थानों द्वारा दावा आवेदन फॉर्म (सीएएफ) जमा करने और राष्ट्रीय आवास बैंक द्वारा दावा आवेदन फॉर्म (सीएएफ) की स्वीकृति के अधीन है। जैसा कि आप जानते हैं कि एकीकृत वेब पोर्टल में दावा आवेदन फॉर्म जमा करने और स्वीकार करने की समान प्रणाली आज ही उपलब्ध कराई गई है, प्राथमिक ऋणदाता संस्थान द्वारा दावा आवेदन फॉर्म की अंतिम प्रस्तुति और केंद्रीय नोडल एजेंसी द्वारा इसकी स्वीकृति के लिए कुछ समय की आवश्यकता होगी।

उपरोक्त को ध्यान में रखते हुए, अभी तक एक केंद्रीय नोडल एजेंसी के रूप में राष्ट्रीय आवास बैंक के लिए अगले एक महीने की सब्सिडी राशि की आवश्यकता का पूर्वानुमान लगाना कठिन है।

हालाँकि, उपरोक्त चर्चा के अनुसार, फिलहाल राष्ट्रीय आवास बैंक को केंद्रीय नोडल एजेंसी के रूप में ₹50 करोड़ की धनराशि जारी की जा सकती है। राष्ट्रीय आवास बैंक द्वारा उचित समय पर संसाधित और स्वीकार किए गए आवेदनों के आधार पर इसे संबंधित प्राथमिक ऋणदाता संस्थानों को वितरित किया जाएगा।
