**Sub.: Mother sanction for release of ₹32.97 lakh to State Govt. of Tripura as balance amount of 1<sup>st</sup> installment of Central Assistance for SLTC and 9 CLTCs for FY 2025-26 under Capacity Building activities of PMAY-U 2.0 Mission - reg.**

Sir,

I am directed to convey the mother sanction of the Competent Authority to release an amount of **₹32,97,000/- (Rupees Thirty Two Lakh and Ninety Seven Thousand only)** to State Govt. of Tripura as balance amount of 1<sup>st</sup> installment of Central Assistance for SLTC with 8 Specialists and 9 CLTCs with 23 Specialists for FY 2025-26 under Capacity Building activities of Pradhan Mantri Awas Yojana – Urban 2.0 (PMAY-U 2.0) Mission under SLS TR284 - Other Component (PMAY-U 2.0) Tripura through SNA SPARSH. Details are enclosed at **Annexure-I & II** and also as under:

2. Earlier, fund of ₹7.59 lakh was released to State Govt. of Tripura as 2<sup>nd</sup> installment of Central Assistance for 16 CLTCs with 16 Specialists for FY 2024-25 by adjusting unspent Central Assistance of ₹3.22 lakh released for SLTC with 3 Specialists for FY 2024-25 under Capacity Building activities of PMAY-U Mission vide sanction letter No. N-11012/35/2024-HFA-V-MoHUA (FTS-9187763) dated 01.02.2025. The State Govt. has submitted the entire Utilization Certificate (UC) against the said release, which is **attached** herewith.

3. State Govt. of Tripura has also submitted the documents required for release of 1<sup>st</sup> installment of Central Assistance for SLTC with 8 Specialists and 9 CLTCs with 23 Specialists for FY 2025-26 under Capacity Building activities of PMAY-U 2.0 Mission.

4. The above grant is subject to the following conditions:

- The State will comply with the terms and conditions stipulated in the guidelines as per scheme guidelines under PMAY-U 2.0.






- ii. The State will utilize the sanctioned grant for the purpose for which it is released. The State Govt./Nodal Agency shall furnish physical and financial progress reports every quarter.
  - iii. The State will furnish the details of expenditure/UC as per GFR 2017 along with the details of Specialists engaged as per scheme guidelines under PMAY-U 2.0.
  - iv. Further installment of funds will be considered on receipt of details of expenditure/UC from the State Govt. along with details of Specialists engaged as per scheme guidelines under PMAY-U 2.0, furnishing clarifications/supporting documents and submission of pending UCs under PMAY-U, if any.
  - v. The State Govt./Nodal Agency shall strictly monitor the progress of the preparatory work. All bills/voucher etc. should be safely kept at SLNA level for future audit and other references.
  - vi. The amount of Central Assistance approved will form a part of capacity building plan of the State under PMAY-U 2.0.
  - vii. Transfer of funds to different entities, if any may be made through PFMS, as applicable and where there is an element of cash transfer to individuals, the same may be made through DBT/EAT module of PFMS mode, as applicable.
  - viii. Any unspent balance lying in State Treasury/SNA Accounts prior to onboarding of the State Government on SNA SPARSH will be subject to guidelines issued by Department of Expenditure (DoE) from time to time.
5. The expenditure involved is debitable to the following Head of Account under Demand No. 60 of Ministry of Housing and Urban Affairs for the year 2025-26:

6. This admissible Central liability will be released to the Govt. of Tripura on demand through SNA SPARSH only or/and as per the latest guidelines of DoE. As the State has on boarded SNA SPARSH, all the committed liabilities shall be released in SNA SPARSH only. The State Govt. is required to contribute approved State matching share under the scheme. The State to ensure timely release of State matching share.
7. As per rule 236(1) of GFR, 2017, the relevant accounts of the Grantee Institution(s)/Organisation(s) shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act 1971 and internal audit by the Principal Accounts Office of the Ministry or Department, whenever the Institution or Organisation is called upon to do so.
8. This issues with the concurrence of the Integrated Finance Division vide **Notes # 46-47 of even number dated 29.08.2025.**

9. The sanction has been registered at **S. No. 137** in the Sanction Register of HFA Directorate (HFA-III Section) of the Ministry of Housing and Urban Affair for the year 2025-26.
